The lobbyist shall file a Notice of Lobbying (Form 4) detailing each instance of lobbying to the Aviation Authority within 7 calendar days of such lobbying. Lobbyists will also provide a notice to the Aviation Authority when meeting with the Mayor of the City of Orlando or the Mayor of Orange County at their offices. ITEM DESCRIPTION

Anticipated Award of an Addendum to the Continuing Transportation Planning Services Agreement with HDR Engineering, Inc. (HDR) to perform 2023 Easter MCO Traffic Count Program at the Orlando International Airport

BACKGROUND

Since 2001, the Aviation Authority has conducted annual roadway traffic counts throughout the Orlando International Airport (MCO) campus. The field data is collected within a seven day period at the busiest time of the year for passenger traffic, which historically has been the time leading up to the Easter Holiday.

The field data is subsequently analyzed and summarized into a report that is utilized by the Aviation Authority Staff to forecast roadway traffic, pinpoint areas of traffic deficiencies and identify areas for infrastructure improvements. Collecting the field data at the same time period each year relative to the Easter Holiday and not a specific date, allows for normalized comparison to other years for more accurate conclusions.

This year, Easter falls on April 9th and the seven day field traffic count data is scheduled to be collected the week before Easter, April 2nd through April 8th. In order to accomplish this time table, approval must be provided to the consultant by March 28, 2023.

HDR's proposal to perform this work was received and has been prepared for Procurement Committee approval, anticipated to be on March 28, 2023. However, since the next Aviation Authority Board meeting is not until April 19, 2023, after Easter, the timeframe to collect the field data would have passed.

The award for the 2023 Easter MCO Traffic Count Program is \$89,949.00, and includes a Minority and Women Business Enterprises (MWBE) participation of 46.7% of the total award.

Including this award, HDR will have been awarded a total of \$441,959 since October 2021 under this contract.
