The lobbyist shall file a Notice of Lobbying (Form 4) detailing each instance of lobbying to the Aviation Authority within 7 calendar days of such lobbying. Lobbyists will also provide a notice to the Aviation Authority when meeting with the Mayor of the City of Orlando or the Mayor of Orange County at their offices. ITEM DESCRIPTION

Recommendation to Accept Public Transportation Grant Agreements (PTGA) for Orlando International Airport from the Florida Department of Transportation (FDOT)

BACKGROUND

Throughout the year, FDOT provides grants (i.e., PTGA) to match funds with the Aviation Authority for certain projects in accordance with the Aviation Authority's Capital Improvement Program.

ISSUES

The Aviation Authority has received the following PTGA from FDOT for Orlando International Airport in support of BP No. S00196, Terminal C, Phase 1X - Airfield Civil, Apron and Taxiway Paving, and Ground Support Equipment Facility. This project will complete the apron and airfield for the Phase 1 Expansion portion of Terminal C. The apron will serve four Multiple Apron Ramp System (MARS) gates which can also serve up to eight narrow body equivalent aircraft. The construction of the apron pavement and associated aircraft hardstand parking area is a priority because of the aircraft operational benefits and to facilitate the building of the additional gates. The expanded apron will also offer the added benefit of being adjacent to aircraft apron hardstand areas where idle aircraft with longer layover times can be towed and staged to allow other aircraft to use the gate position.

PTGA FM 448578-1-94-03. This PTGA in the amount of \$5,000,000 provides 12.5% matching funding to the
forthcoming Federal Aviation Administration (FAA) Bipartisan Infrastructure Law (BIL) Airport
Infrastructure Grant (AIG) for the Terminal C Phase 1 Apron, Airfield and Taxiway project. This is the first
increment of matching funds required to support BP No. S00196 construction, with supplemental PTGA
funding anticipated during FDOT's next fiscal year.

FISCAL IMPACT

The fiscal impact is the acceptance of FDOT funding in the amount of \$5,000,000. the Aviation Authority's matching funds in the amount of \$5,000,000 will be from Passenger Facility Charges to the extent eligible and General Airport Revenue Bonds.

RECOMMENDED ACTION

It is respectfully requested that the Aviation Authority Board ratify the Resolution accepting: (1) PTGA FM 448578-1-94-03; and, (2) authorize the Chief Executive Officer and the Assistant Secretary to execute the necessary documents.
