For individuals who conduct lobbying activities with Aviation Authority employees or Board members, registration with the Aviation Authority is required each year prior to conducting any lobbying activities. A statement of expenditures incurred in connection with those lobbying instances should also be filed prior to April 1 of each year for the preceding year. Lobbying any Aviation Authority Staff who are members of any committee responsible for ranking Proposals, Letters of Interest, Statements of Qualifications or Bids and thereafter forwarding those recommendations to the Board and/or Board Members is prohibited from the time that a Request for Proposals, Request for Letters of Interests, Request for Qualifications or Request for Bids is released to the time that the Board makes an award. In the event a lobbyist with or otherwise communicates with Staff or a Board member, including the Mayor of the City of Orlando or the Mayor of Orange County, the lobbyist shall file a Notice of Lobbying (Form 4) detailing each instance of lobbying to the Aviation Authority within 7 calendar days of such lobbying. Lobbyists will also provide a notice to the Aviation Authority when meeting with the Mayor of the City or Mayor of Orange County at their offices. The policy, forms, and instructions are available on the web site. Please contact the Director of Board Services with questions at (407) 825-2032.

Before proceeding to business, Chairman Brown asked Committee members to report any conflicts of interest or violations of the Aviation Authority's Code of Ethics and Business Conduct; lobbying activities policy; or the Florida Sunshine law with regard to the agenda item. Mr. Thornton stated that he had no conflicts to discuss. He did report that he worked for Hubbard Construction 33 years ago. Both Chairman Brown and Mr. Draper affirmed that they do not have any conflicts.

ACCEPT THE DISPUTE REVIEW BOARD (DRB) HEARING RECOMMENDATION ON BP-486, RUNWAY 18L - 36R REHABILITATION AND RELATED WORK

2. Mr. Patterson presented the item.

The scope of work in the BP-486 project included the replacement of 81 concrete slabs of varying sizes. During the execution of the replacement work, 7 slabs cracked and had to be removed and replaced. Hubbard Construction Company and their subcontractor, Gosalia Concrete Company (HCC/GCC) submitted a claim seeking reimbursement of the costs to replace these 7 slabs, claiming design defects caused the cracking. The Aviation Authority found no entitlement for reimbursement based on the claim substantiation submitted. In June 2020, HCC/GCC requested a DRB hearing to hear the dispute. Position papers and rebuttals were prepared and exchanged in July and August 2020, and the DRB hearing was held on August 12, 2020. The DRB rendered its recommendation on entitlement on August 18, 2020. The DRB found in favor of the Aviation Authority, citing the contractors failure to follow the contract specifications, specifically, failing to prepare a hot weather placement plan.

The DRB process requires that the two parties accept or reject their recommendation within 15 days of its receipt. The response is due by September 1, 2020.

The estimated cost of the replacement slabs was \$250,000.

It was respectfully requested that the Capital Management Committee consense to accept the Dispute Review Board hearing recommendation on BP-486, Runway 18L-36R Rehabilitation and Related Work
