For individuals who conduct lobbying activities with Aviation Authority employees or Board members, registration with the Aviation Authority is required each year prior to conducting any lobbying activities. A statement of expenditures incurred in connection with those lobbying instances should also be filed prior to April 1 of each year for the preceding year. Lobbying any Aviation Authority Staff who are members of any committee responsible for ranking Proposals, Letters of Interest, Statements of Qualifications or Bids and thereafter forwarding those recommendations to the Board and/or Board Members is prohibited from the time that a Request for Proposals, Request for Letters of Interests, Request for Qualifications or Request for Bids is released to the time that the Board makes an award. As adopted by the Board, lobbyists are now required to sign-in at the Aviation Authority offices prior to any meetings with Staff or Board members. In the event a lobbyist meets with or otherwise communicates with Staff or a Board member at a location other than the Aviation Authority offices, the lobbyist shall file a Notice of Lobbying (Form 4) detailing each instance of lobbying to the Aviation Authority within 7 calendar days of such lobbying. Lobbyists will also provide a notice to the Aviation Authority when meeting with the Mayor of the City of Orlando or the Mayor of Orange County at their offices. # PRESENTATION OF THE AVIATION AUTHORITY'S ANNUAL COMPREHENSIVE FINANCIAL REPORT (DRAFT COPY) FOR THE YEAR ENDED SEPTEMBER 30, 2021

2. Ms. Sharman introduced Mr. Dan O'Keefe, MSL, who presented the Independent Auditor's Report for Fiscal Years Ended September 30, 2021 and 2020. A copy of the report is on file.

Mr. O'Keefe stated that this is an unmodified/clean opinion, which is the best that one can receive. Referring to page 2 of the report, Mr. O'Keefe highlighted a new government accounting standard relating to fiduciary activities. He stated this standard requires fiduciary statements of the Retirement Plan to be included in the financial statements of the Annual Comprehensive Financial Report; and will now be audited annually. He then reported on the compliance findings for each major federal program, major state project, and the passenger facility charge program, the summary schedule of prior audit findings, and the internal controls over financial reporting and other matters.

Next, Ms. Sharman provided an update on the Bond sale, reporting that on February 7 and 8, the Aviation Authority sold \$287M at an interest rate of 3.23%. She announced the closing would happen on February 22, 2022
