

# ***SECOND ANNUAL #FlyMCO PLANESPOTTING***

## ***EXHIBIT OFFICIAL RULES***

### **OFFICIAL RULES**

By providing an entry to the Second Annual #FlyMCO Planespottling Exhibit, each participant represents and warrants that they meet the eligibility requirements detailed within these official rules and acknowledges that failure to meet all eligibility requirements will result in disqualification. Any entry constitutes your acceptance of these official rules.

### **ELIGIBILITY**

NO PURCHASE NECESSARY TO ENTER OR WIN.

Entries are accepted from April 26, 2024, through May 6, 2024, 11:59 PM (ET). (“Competition Entry Period”).

Competition entries will be accepted per the rules of the Greater Orlando Aviation Authority (GOAA). Two entries per person will be accepted.

GOAA reserves the right to disqualify any Entrant who, in its sole discretion, tampers with the entry process, violates these Official Rules, or acts in an unsportsmanlike or disruptive manner.

Entries that do not satisfy all requirements will be disqualified and will not be considered. Eligibility is determined by competition judges and their decision is final.

Competition is open to plane spotters worldwide, including current employees of GOAA and their immediate family members, as well as any other airport employees and partners of the Greater Orlando Aviation Authority.

### **HOW TO ENTER**

Entries should be submitted via email to: [socialmedia@goaa.org](mailto:socialmedia@goaa.org). Photo can be in .jpg, .jpeg, or .png format and should not exceed 10MB in size. Photo must be taken by Entrant (Entrant must own the rights to the photo), it can be in color or black and white, and uploaded in compliance with the Competition requirements. Photo should be taken within the last five years by spotters at our facilities. The subject matter of the photos should be the exterior of aircraft. All entries must be received during the Competition Entry Period only.

Once an entry is submitted via email, the submission is final and may not be modified or edited. Any automated computer receipt (such as one confirming delivery of entry) does not constitute proof of actual receipt for purposes of these Official Rules. An official email reply will be provided to all email entries confirming receipt. All entries eligible for the Competition will be prescreened by the Greater Orlando Aviation Authority.

By submitting a photo, the Entrant understands and grants permission for the photo to be published on any social media platform, website, online or publication and for public viewing at Second Annual

#FlyMCO Planespotting Exhibit at the Orlando International Airport. GOAA is not responsible for any unauthorized third-party use of any photo.

Except where prohibited by law, entry submission grants GOAA the right in perpetuity to reproduce, publish or use such photo and/or comments in any way, in any and all media, without limitation and without compensation to Entrant. Proper photo name credits will be included if that occurs.

Submission of photo in the Competition further constitutes Entrant's consent to publish and/or promote photo, or a portion of a photo. If a photo, or a portion of photo is selected for publication and/or promotional purposes, it does not create a relationship between you and GOAA or any of its respective affiliates or subsidiaries.

Entries must comply with the following content guidelines to be eligible:

- Entry must be an original digital photo created solely by the Entrant.
- Photo entry should be taken within the past five years at Orlando International Airport (MCO).
- Plagiarism will result in disqualification.
- All entries must be received no later than 11:59 PM (ET) on May 6, 2024. Entries submitted after the deadline will not be valid.
- Photo entry can be in .jpg, .jpeg or .png format and should not exceed 10MB in size. Photo must be taken by Entrant (Entrant must own the rights to the photo). Photo can be in color or black and white, and uploaded in compliance with the Competition requirements.
- Title + Date + Author's name and Social Media Handle should be provided for each photo entry.
- Image aspects should be 24x36 inches (landscape or portrait mode) - minimum of 300 DPI quality.
- GOAA reserves the right to disqualify any entry for any reason, in its sole and absolute discretion.

At the conclusion of the Entry period, a panel of judges comprising GOAA personnel and consultants ("Judges") will determine winners utilizing the following judging criteria: Most Creative, 50%; Originality, 25%; and Technical Skills, 25%. Judges' decisions are final and binding. Only winners will be notified.

GOAA reserves the right to not hold the exhibit, in its sole and absolute discretion, if it does not receive a sufficient number of eligible and qualified entries for this exhibit or at its own discretion.

### **WINNER NOTIFICATION**

Winners will be notified by the end of May 2024, via email. Winners also will be announced on the MCO social media accounts. GOAA shall have the right to modify, suspend, extend or terminate the Competition and Exhibit at its own discretion. Winners will also have the opportunity to participate at an airfield tour to get an up-close experience by spotting aircraft at our airfield (date will be announced to all winners and determined at a later date).

### **EXHIBIT**

The Second Annual #FlyMCO Planespotting Exhibit, featuring the winning photographs taken by spotters at MCO, will take place at the Orlando International Airport. Exhibit will be held at the Gallery MCO, located on Terminal B, Level 3.

A total of 12 to 15 winning photographs will be displayed in the Exhibit. Title + Date + Author's name and Social Media Handle will be included on an identifying label by the photographs on display. All printing

and framing of the photographs will be provided by GOAA, at no cost to the selected winners of this Exhibit.

The Exhibit will be on public display from Friday, June 7, 2024, through Tuesday, September 3, 2024 (12 weeks). An opening reception for the Exhibit will take place on the evening of Tuesday, June 11, 2024. Winners will be notified via email of event details, closer to the Exhibit date. GOAA shall have the right to modify, suspend, extend or terminate the Exhibit, reception or airfield tour at its own discretion.
