## ITEM DESCRIPTION

Recommendation to Purchase Two (2) Aircraft Rescue Fire Fighting (ARFF) Vehicles from Rosenbauer Minnesota, LLC Utilizing Sourcewell Contract No. 113021-RSD

## **BACKGROUND**

The Aviation Authority's Aircraft Rescue and Fire Fighting (ARFF) Department provides fire suppression, aircraft and structural, emergency medical services with transport capabilities and special teams operations such as high-angle and confined space rescue via three (3) ARFF stations strategically located around the airfield. The department currently has in service four (4) ARFF vehicles on a twenty-four (24) hour basis with one (1) ARFF vehicle as a reserve.

The Federal Aviation Administration (FAA) has set standards that an airport must meet to remain certified and able to operate. ARFF Standards include the number of vehicles required to be in service because of their firefighting capabilities per the size of the aircraft that operate at the airport. Orlando International Airport (MCO) is an index E airport, the largest category. Per the FAA standard (FAR 139.315, Aircraft rescue and firefighting: Index determination) & Advisory Circular (AC) 150/5220-10E for vehicle firefighting capabilities MCO is required to have in service three (3) ARFF vehicles. Due to the size of MCO's airfield the FAA increased the vehicle requirement to four (4) ARFF vehicles, which is currently in service at all times. The FAA also mandates the in-service life of the vehicle which was ten (10) years, approximately five (5) years ago that life span was increased to fifteen (15) years.

The FAA standard (FAR 139.319, Aircraft rescue and firefighting, operational requirements) also address ARFF response times on the airfield. The first ARFF vehicle must be at the midpoint of the furthest runway in under three (3) minutes with the remaining vehicles under four (4) minutes. To best accomplish this the ARFF vehicles are strategically positioned on the airfield. FAA response drills are routinely conducted to ensure that this time can be achieved.

Lastly, the FAA mandates driver proficiency (AC 150/5210-17C & AC 150/5210-23) on all ARFF Apparatus, in service and reserve. Each operator must conduct up to twelve (12) hours of driver training per quarter on each type of ARFF vehicle to remain proficient. Currently the Authority's ARFF department has approximately fifty (50) operators on four (4) different vehicles. Notwithstanding any emergencies, each ARFF Vehicle is operated each quarter at near emergency conditions approximately six-hundred (600) hours. With all of the technology now on these units, this much activity is very hard on the unit.

#### **ISSUES**

This request is to purchase of two (2) ARFF Vehicles. One (1) ARFF Vehicle is nearing the end of the FAA mandated in service life of 2024. Current schedule from the manufacturer is approximately fifteen (15) months, or second quarter of 2024 barring manufacturing or supply chain issues. The second ARFF Vehicle will be an additional vehicle to raise the in-service fleet from four (4) to five (5) ARFF Vehicles. Previous FAA annual certification inspection noted that due to the increased aircraft activity on the East airfield complex it is becoming difficult for ARFF to ensure the required response times. The FAA recommendation is to add another ARFF Vehicle to the East field ARFF Station.

This purchase will be made from Rosenbauer Minnesota, LLC. based on a Government Contract/Annual Contract in accordance with Aviation Authority Policy 450.03: The Aviation Authority may acquire Goods, Services and Professional Services by Direct Negotiation or other method involving limited or no competition from a Supplier having a requirements contract, annual agreement, or multi-year contract with any public entity (e.g., federal, state, county, city, authority, school board, Buying Cooperative, etc.) for Goods, Services, or Professional Services described in such contract and at prices or discounts no less favorable than any set forth in such Contracts.

Pursuant to the terms of Sourcewell Contract No. 113021-RSD, Rosenbauer Minnesota, LLC has proposed the price of \$985,861.00 for the first vehicle and \$1,015,480.00 for the second vehicle for a total of \$2,001,341.00 for both vehicles.

SBDD determined no small business goals for Minority and Women Business Enterprise, Local Developing Business and/or Veteran Business Enterprise participation, due to SBDD cannot change the terms and conditions of an existing contract such as Sourcewell Contract No. 113021-RSD and due to the specialized scope.

#### **ALTERNATIVES**

There are no reasonable alternatives under consideration.

## **FISCAL IMPACT**

The value of this procurement is a not-to-exceed amount of \$2,001,341.00. Funding will be allocated from the Capital Expenditure Fund.

# **RECOMMENDED ACTION**

It is respectfully requested that the Procurement Committee approve that the following be recommended to the Aviation Authority Board: 1) approve the purchase of two (2) Aircraft Rescue Fire Fighting (ARFF) vehicles from Rosenbauer Minnesota, LLC utilizing Sourcewell Contract No. 113021-RSD; 2) authorize funding from the Capital Expenditure Fund in the not-to-exceed amount of \$2,001,341.00.; and 3) authorize an Aviation Authority officer or the Chief Executive Officer to execute the necessary documents following satisfactory review by legal counsel.
