#### **ITEM DESCRIPTION**

Recommendation to Approve Amendment No. 3 to Fuel System Lease Agreement at Orlando International Airport, with Orlando Fuel Facilities, LLC

#### BACKGROUND

The Greater Orlando Aviation Authority (Aviation Authority) and Orlando Fuel Facilities, LLC are parties to a Fuel System Lease Agreement (Lease), dated March 1, 2009, as amended (the "Agreement") for the operation and maintenance of the Fuel System, as defined in the Agreement, at Orlando International Airport. The Agreement expires in 2038.

### ISSUES

The Aviation Authority is completing construction of Terminal C which includes the Temporary Terminal C GSE Fuel Island to accommodate GSE equipment fueling at Terminal C. The Temporary Terminal C GSE Fuel Island is not currently identified in the Lease and requires this Board's approval to be added. This amendment also makes a one-time adjustment to increase the Non-Contracting user fee from \$0.0348 to \$0.125 per gallon. This rate has not been adjusted since 2011 and requires the Aviation Authority's approval, pursuant to the Lease. After this adjustment, the rate will be the greater of (i) \$0.125 or (ii) 150% of the member rate.

#### ALTERNATIVES

No alternatives are being considered at this time.

#### **FISCAL IMPACT**

An estimated \$9,959.00 in additional annual rent paid to the Aviation Authority. Also, the Aviation Authority will also receive 7/15<sup>ths</sup> of the \$0.125 per gallon, or \$0.0584 per gallon of the Non-Contracting Users fees collected by the Fuel System Operator.

#### **RECOMMENDED ACTION**

It is respectfully requested that the Aviation Authority Board resolve to (1) approve Amendment No. 2 to Fuel System Lease Agreement at Orlando International Airport, with Orlando Fuel Facilities, LLC; and (2) authorize an Aviation Authority Officer or Chief Executive Officer to execute the necessary documents following satisfactory review by legal counsel.

# AMENDMENT NO. 3 TO FUEL SYSTEM LEASE AGREEMENT

This Amendment No. 3 to the Fuel System Lease Agreement (this "Amendment No. 3") is made and entered into as of this 2 day of 2 2022, by and between the Greater Orlando Aviation Authority, a public body corporate existing under the laws of the State of Florida (the "Authority"), and Orlando Fuel Facilities LLC, a limited liability company organized and existing under the laws of the State of Delaware and authorized to do business in the State of Florida ("Lessee").

# Background

A. Authority and Lessee are parties to a Fuel System Lease Agreement made and entered into with an effective date of March 1, 2009, as amended by that certain Amendment No. 1 to Fuel System Lease Agreement made and entered into with an effective date of September 1, 2013, and that certain Amendment No. 2 to Fuel System Lease Agreement made and entered into with an effective date of December 21, 2021 (the "Agreement"); and

B. Pursuant to that certain Amended and Restated Operation and Use Agreement, dated August 30, 2015, by and between the Authority and the City of Orlando ("City"), the Authority controls, operates and maintains the airport in Orange County, Florida, known as Orlando International Airport ("Airport"); and

C. Authority and Lessee desire to further amend the Agreement in the manner set forth below.

# Agreement

NOW, THEREFORE, in consideration of the mutual promises and agreements hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound, hereby agree as follows:

1. <u>Recitals</u>. The above recitals are true and correct and are incorporated herein by this reference.

2. <u>Definitions</u>. Capitalized terms herein shall have the definition ascribed to them in the Agreement, unless otherwise defined herein.

3. <u>Temporary Terminal C GSE Fuel Island.</u> Exhibit "A" is here by amended to add the area entitled Interim GSE Fueling Location as shown on Exhibit "1," attached hereto and incorporated herein, to the Demised Premises (the "Temporary GSE Fuel Island").

4. <u>Section 6.4.1</u>. Section 6.4.1 of the Agreement is hereby deleted in its entirety and replaced with the following:

"6.4.1. Hydrant Fuel System Fee. Lessee shall charge Non-Contracting Users a fee for use of the Fuel System, up to a maximum fee equal to the greater of (a) \$0.125 per gallon or (b) one hundred fifty percent (150%) of the highest Member rate, in accordance with the paragraph titled "Computation for Purposes of Determining Non-Contracting User Fee" in attached Exhibit D. The Members shall pay Lessee the Member rates for using the Fuel System, and the basis for computing the Member rates is set forth in the Lessee Agreements and is summarized on the attached Exhibit D. Lessee shall remit to the Authority seven-fifteenths (7/15ths) of the fees collected pursuant to this Section 6.4.1 from Non-Contracting Users, which amounts shall be collected by Lessee as agent for the Authority and shall be in addition to any Fuel System Rent or Ground Rent owed by Lessee hereunder. Lessee shall retain the remainder of the fees collected pursuant to this Section 6.4.1 solely for the purposes of paying for Lessee's rent, operations, and maintenance expenses for the Fuel System. Lessee may not change the fees charged pursuant to this Section 6.4.1 without the prior written consent of the Authority, which consent may not be unreasonably withheld, conditioned or delayed. The Authority may increase the fee charged to Non-Contracting Users pursuant to this Section 6.4.1 in the Authority's reasonable discretion."

5. <u>Binding Agreement</u>. This Amendment shall be binding on and inure to the benefit of the parties hereto and their respective successors and assigns.

6. <u>**Ratification**</u>. Except as expressly amended by Amendment No. 1, Amendment No. 2 and this Amendment No. 3, the Agreement shall continue in full force and effect in accordance with its terms.
