

**ADDENDUM NO. 12
TO THE AGREEMENT
DATED MAY 15, 2019
BETWEEN

AND AC SIGNS, LLC**

Project: Additional Renewal Option, Orlando International and Executive Airports

THIS ADDENDUM is effective this 24th day of April, 2024, by and between the **GREATER ORLANDO AVIATION AUTHORITY** (“Aviation Authority”), and **AC SIGNS, LLC** (“Contractor”).

WITNESSETH:

WHEREAS, by Agreement dated May 15, 2019, Aviation Authority and Contractor entered into an agreement for Contractor to provide Continuing Signage Construction services; and

WHEREAS, the Aviation Authority and Contractor desire to enter into this Addendum to the Agreement to exercise an additional renewal option to extend the Agreement.

NOW, THEREFORE, in consideration of the premises and the mutual covenants herein contained, the Aviation Authority and the Contractor do hereby agree as follows:

1. The term of the additional renewal option to the Agreement shall be for the period from May 15, 2024 to March 31, 2025, as more fully described in the attached Exhibit “A.” Contractor shall perform all services authorized during the extension period in accordance with the terms and conditions set forth in the Agreement.
2. Except as expressly modified in this Addendum, the Agreement dated May 15, 2019 and all prior addenda will remain in full force and effect.

ITEM DESCRIPTION

Request for Recommendation of Approval of No-Cost Addenda to the Continuing Signage Services Agreements to Extend the Contract Term through March 31, 2025

BACKGROUND
