THIS ADDENDUM is effective this 11 day of April, 2022, by and between the **GREATER ORLANDO AVIATION AUTHORITY** ("Authority"), and **ADVANCED CABLE CONNECTION, INC.** ("Contractor").

WITNESSETH:

WHEREAS, by Agreement dated November 1, 2019, Authority and Contractor entered into an agreement for Contractor to provide Continuing Low Voltage Construction services; and


WHEREAS, the Authority and Contractor desire to enter into this Addendum to the Agreement to exercise the first extension and extend the Agreement for an additional one-year period.

NOW, THEREFORE, in consideration of the premises and the mutual covenants herein contained, the Authority and the Contractor do hereby agree as follows:

1. The term of the first extension to the Agreement shall be for a period of one (1) year from November 1, 2022 to November 1, 2023, as more fully described in the attached Exhibit "A." Contractor shall perform all services authorized during the extension period in accordance with the terms and conditions set forth in the Agreement.
2. Except as expressly modified in this Addendum, the Agreement dated November 1, 2019 and all prior addenda will remain in full force and effect.



SUBJECT: Request for Recommendation of Approval of No-Cost Addenda to the Continuing Low Voltage Construction Services Agreements to Exercise the First One-Year Renewal Option

In July 2019, the Aviation Authority Board approved Continuing Low Voltage Construction Services Agreements with the below firms. The provisions in the agreements include a base three-year term with two subsequent optional one-year renewal periods upon mutual agreement of the parties. Each firm's base agreement term expires as follows:

ITEM DESCRIPTION

Recommendation of the Construction Committee to Approve No-Cost Addenda to the Continuing Low Voltage Construction Services Agreements to Exercise the First One-Year Renewal Option

BACKGROUND

In 2019, the firms providing Continuing Low Voltage Construction Services were selected through a competitive award process. These services are procured on an as-needed or annual basis. The Aviation Authority's policy and procedure provides that construction firms may be engaged through continuing services agreements for construction projects with a value of \$4,000,000 or less.

On July 17, 2019, the Aviation Authority Board approved Continuing Low Voltage Construction Services Agreements with the following seven firms:

- Advanced Cable Connection, Inc. (MWBE)
- Archis Inc. dba Archis Technologies (DBE/MWBE/LDB)
- Certified Network Professionals, Inc. (DBE/MWBE)
- Orion Management Services, LLC (VBE)
- Orlando Business Telephone Systems, Inc.
- Precision Contracting Services, Inc.
- Quality Cable Contractors, Inc.

These agreements provide continuing low voltage construction services which include, but are not limited to, furnishing all labor, supervision, tools, fiber and copper circuit test equipment and other equipment, parts, materials and all other items necessary or proper for, or incidental to, installing low voltage voice and data wiring, conduit and rack pathways, related electrical power distribution to IT equipment, and any other necessary components for a complete Premise Distribution System (PDS), and Outside Plant (OSP) backbone cabling and pathways system serving complete voice, video and data, wireless and cellular and security cabling subsystems.

The terms of these continuing agreements include a three-year service agreement with optional renewal periods of two additional one-year terms upon mutual agreement of the Aviation Authority and the contractor.

The current agreements will expire as follows:

All seven firms have been responsive to the Aviation Authority's needs.

ISSUES

To maintain continuing low voltage construction services on an as-needed basis, the first renewal option is required for each of the agreements. In response to the Aviation Authority's notification, all seven firms have provided a letter of concurrence of the first one-year renewal option.

On March 22, 2022, the Construction Committee recommended approval of a No-Cost Addendum to each of the Continuing Low Voltage Construction Services Agreements to exercise the first one-year renewal option, as outlined in the memorandum.

ALTERNATIVES

The Aviation Authority Board could request staff to advertise for new Continuing Low Voltage Construction Services.

FISCAL IMPACT

There is no fiscal impact for these addenda. Future addenda will be based on specific tasks of work as assigned with approved funding source.

RECOMMENDED ACTION

It is respectfully requested that the Aviation Authority Board resolve to accept the recommendation of the Construction Committee and (1) approve a no-cost Addendum to the Continuing Low Voltage Construction Services Agreement with Advanced Cable Connection, Inc. to exercise the first one-year renewal option and extend the Agreement to November 1, 2023; (2) approve a no-cost Addendum to the Continuing Low Voltage Construction Services Agreement with Archis, Inc. dba Archis Technologies to exercise the first one-year renewal option and extend the Agreement to August 21, 2023; (3) approve a no-cost Addendum to the Continuing Low Voltage Construction Services Agreement with Certified Network Professionals, Inc. to exercise the first one-year renewal option and extend the Agreement to August 20, 2023; (4) approve a no-cost Addendum to the Continuing Low Voltage Construction Services Agreement with Orion Management Services, LLC to exercise the first one-year renewal option and extend the Agreement to August 21, 2023; (5) approve a no-cost Addendum to the Continuing Low Voltage Construction Services Agreement with Orlando Business Telephone Systems, Inc. to exercise the first one-year renewal option and extend the Agreement to August 1, 2023; (6) approve a no-cost Addendum to the Continuing Low Voltage Construction Services Agreement with Precision Contracting Services, Inc. to exercise the first one-year renewal option and extend the Agreement to August 21, 2023; (7) approve a no-cost Addendum to the Continuing Low Voltage Construction Services Agreement with Quality Cable Contractors, Inc. to exercise the first one-year renewal option and extend the Agreement to August 1, 2023; and, (8) authorize an Aviation Authority Officer or the Chief Executive Officer to execute the necessary documents following satisfactory review by legal counsel.
