1. The term of the first extension to the Agreement shall be for a period of one (1) year from February 26, 2024 to February 26, 2025, as more fully described in the attached Exhibit "A." Consultant shall perform all services authorized during the extension period in accordance with the terms and conditions set forth in the Agreement.

2. Except as expressly modified in this Addendum, the Agreement dated February 26, 2021 and all prior addenda will remain in full force and effect.

ITEM DESCRIPTION

Recommendation of the Construction Committee to Approve No-Cost Addenda to the Computer Aided Drafting (CAD), Geographic Information System (GIS), Building Information Modeling (BIM) and Related Consulting Services Agreements to Exercise the First One-Year Renewal Option

BACKGROUND

On February 2, 2021, the Aviation Authority Board approved CAD, GIS and BIM Consulting Services Agreements, following a competitive award process in compliance with the state statutes and Aviation Authority policies, with the following firms:

- CAD Concepts, Inc. dba CCI Engineering Services
- DRMP-AVCON JV, LLC
- EPIC Engineering & Consulting Group, LLC
- Woolpert, Inc.

The scope of services includes, but is not limited to, assisting the Aviation Authority staff with the following services:

- Preparation and updating of the airport facility conceptual layout drawings, Airport Layout Plan (ALP) drawings, graphics, aerial photography and geospatial imagery, base maps, exhibits, floor plans, utility systems and building inventories.
- Integration and management of the airport facility data, airport addressing, land use maps, property surveys and maps, easements and leasehold exhibits, facility management data layers and data attributes, geospatial space planning systems and airport airspace.

The provisions of these agreements include a three-year service agreement with optional renewal periods of two additional one-year terms upon mutual agreement of the Aviation Authority and the consulting firm.

The current agreements will expire as follows:

The firms have been responsive to the Aviation Authority's needs.

ISSUES

To maintain CAD, GIS and BIM consulting services on an as-needed basis, the first renewal option is required for each of the agreements. In response to the Aviation Authority's notification, all four firms have provided a letter of concurrence of the first one-year renewal option.

On October 3, 2023, the Construction Committee recommended approval of a No-Cost Addendum to each of the CAD, GIS and BIM Consulting Services Agreements to exercise the first one-year renewal option, as outlined in the memorandum.

ALTERNATIVES

The Aviation Authority Board could request staff to advertise for new CAD, GIS and BIM Consulting Services.

FISCAL IMPACT

There is no fiscal impact for this addendum. Future addenda will be based on specific tasks of work as assigned with approved funding source.

RECOMMENDED ACTION

It is respectfully requested that the Aviation Authority Board resolve to accept the recommendation of the Construction Committee and approve (1) a no cost Addendum to CAD, GIS and BIM Consulting Services Agreement with CAD Concepts, Inc. dba CCI Engineering Services to exercise the first one-year renewal option and extend the Agreement to February 26, 2025; (2) a no cost Addendum to CAD, GIS and BIM Consulting Services Agreement with DRMP-AVCON JV, LLC to exercise the first one-year renewal option and extend the Agreement to March 12, 2025; (3) a no cost Addendum to CAD, GIS and BIM Consulting Services Agreement with EPIC Engineering & Consulting Group, LLC to exercise the first one-year renewal option and extend the Agreement to February 16, 2025; (4) a no cost Addendum to CAD, GIS and BIM Consulting Services Agreement with Woolpert, Inc. to exercise the first one-year renewal option and extend the Agreement to February 23, 2025; and, (5) authorize an Aviation Authority Officer or the Chief Executive Officer to execute the necessary documents following satisfactory review by legal counsel.
