NOW, THEREFORE, in consideration of the premises and the mutual covenants herein contained, the Authority and the Consultant do hereby agree as follows:

- 1. Consultant shall perform additional services in accordance with the terms of the Agreement and the attached Exhibit "A." Consultant shall be paid for such additional services according to the payment terms set forth in the Agreement.
- 2. Consultant shall be compensated for such additional services in the **NOT TO EXCEED** amount of **FOUR HUNDRED SIXTY-SIX THOUSAND AND NO/100 DOLLARS** (\$466,000.00), broken down as follows:

3. A. Consultant hereby certifies that it is not on the Scrutinized Companies that Boycott Israel List and is not engaged in a boycott of Israel, as defined in Florida Statutes § 287.135, as amended;

AND

- B. (applicable to agreements that may be \$1,000,000 or more) Consultant hereby certifies that it is: (1) not on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List as defined in Florida Statutes § 287.135; and (2) not engaged in business operations in Cuba or Syria, as defined in Florida Statutes § 287.135, as amended.
- 4. Authority may terminate the Agreement for cause and without the opportunity to cure if the Consultant is found to have submitted a false certification or has been placed on the Scrutinized Companies that Boycott Israel List or is engaged in a boycott of Israel.

In the event the Agreement is for One Million Dollars (\$1,000,000.00) or more, Authority may terminate this Agreement for cause and without the opportunity to cure if the Consultant is found to have submitted a false certification or has been placed on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List or is engaged in business operations in Cuba or Syria.

5. Except as expressly modified in this Addendum, the Agreement dated February 19, 2021, and all prior addenda will remain in full force and effect.

Request for Recommendation of Approval to the Aviation Authority Board of an Addendum to the CAD, GIS, BIM & Related Services Agreement with EPIC Engineering and Consulting Group, LLC for FY 2024 Planning, Engineering & Construction Staff Extension for Computer Aided Design (CAD), Geographic Information Systems (GIS), Building Information Modeling (BIM) & Related Services for Orlando International Airport

BACKGROUND

In 2021, the firms providing Computer Aided Drafting (CAD), Geographic Information System (GIS), Building Information Modeling (BIM) and Related Services were selected through a competitive award process. These services are procured on an as-needed or annual basis.

On February 2, 2021, the Aviation Authority Board approved a Computer Aided Drafting (CAD), Geographic Information System (GIS), Building Information Modeling (BIM) and Related Services Agreement with the following firms:

- CAD Concepts, Inc. dba CCI Engineering Services
- DRMP-AVCON JV. LLC
- Epic Engineering & Consulting Group, LLC
- Montgomery Consulting Group, Inc.
- Woolpert, Inc.

These no-cost base agreements established the negotiated hourly rates. These services typically consist of working in the Aviation Authority's offices and using the Aviation Authority equipment to perform and assist the Aviation Authority staff with providing CAD, GIS, BIM and Related Services for the:

- Preparation and updating of the airport facility conceptual layout drawings, Airport Layout Plan (ALP) drawings, graphics, aerial photography and geospatial imagery, base maps, exhibits, floor plans, utility systems and building inventories; and
- Integration and management of the airport facility data, airport addressing, land use maps, property surveys and maps, easements and leasehold exhibits, facility management data layers and data attributes, geospatial space planning systems and airport airspace.

ISSUES

Consultant's proposal, dated June 9, 2023, is to provide Onsite CAD, GIS, BIM and Related Technical Support Services.

If approved, these services would be effective October 1, 2023 and would last through September 30, 2024.

SMALL BUSINESS

The MWBE/LDB/VBE participation has been reviewed by the Office of Small Business Development (OSBD). The findings and recommendation are attached.

FISCAL IMPACT

The fiscal impact is \$466,000.00. Funding is from Operation and Maintenance Funds, contingent upon Aviation Authority Board adoption of the FY2024 Aviation Authority budget.

Recommendation of the Procurement Committee to Approve an Addendum to the Computer Aided Drafting (CAD), Geographic Information System (GIS), Building Information Modeling (BIM) and Related Services Agreement with EPIC Engineering and Consulting Group, LLC for Fiscal Year (FY) 2024 CAD, GIS, BIM and Related Services

BACKGROUND

On February 2, 2021, the Aviation Authority Board approved CAD, GIS, BIM, and Related Consulting Services Agreements with the following firms, following a competitive award process in compliance with state statutes and Aviation Authority policies:

- CAD Concepts, Inc. dba CCI Engineering Services
- DRMP-AVCON JV, LLC
- EPIC Engineering and Consulting Group, LLC (MWBE/LDB)
- Montgomery Consulting Group, Inc. (MWBE/LDB)
- · Woolpert, Inc.

The agreements are structured as a no-cost base agreement with negotiated hourly rates. Services that are within the advertised scope are negotiated on an as-needed or annual basis, and awarded as addenda to the base agreement. The terms of the agreements shall be for a period of three years with optional renewal periods of two additional one-year terms, to be exercised at the discretion of the Aviation Authority and accepted by both parties.

EPIC Engineering and Consulting Group, LLC will provide services that include, but are not limited to, working in the Aviation Authority's offices and using the Aviation Authority equipment to perform and assist the Aviation Authority staff with the following services:

- Preparation and updating of the airport facility conceptual layout drawings, Airport Layout Plan
 (ALP) drawings, graphics, aerial photography and geospatial imagery, base maps, exhibits, floor
 plans, utility systems and building inventories.
- Integration and management of the airport facility data, airport addressing, land use maps, property surveys and maps, easements and leasehold exhibits, facility management data layers and data attributes, geospatial space planning systems and airport airspace.

ISSUES

A fee has been negotiated with EPIC Engineering and Consulting Group, LLC for a total amount of \$466,000 for FY 2024 CAD, GIS, BIM and Related Services. These services include, but are not limited to, preparation of ongoing updates of CAD drawings and GIS data sets; database consolidation planning

and data integration into the Aviation Authority's Enterprise GIS system; related GIS and CAD planning, analysis, and input as needed; preparation and updating of the airport facility conceptual layout drawings, Airport Layout Plan (ALP) drawings, graphics, aerial photography and geospatial imagery, base maps, exhibits, floor plans, utility systems and building inventories; integration and management of the airport facility data, airport addressing, land use maps, property surveys and maps, easements and leasehold exhibits, facility management data layers and data attributes, geospatial space planning systems and airport airspace; and, assistance of Aviation Authority staff on various projects as requested. Services will be provided from October 1, 2023, through September 30, 2024. At the discretion of the Aviation Authority, the level of provided services may be adjusted during the fiscal year, depending on fluctuations of Aviation Authority staffing levels.

On August 1, 2023, the Procurement Committee recommended approval of an Addendum to the CAD, GIS, BIM and Related Services Agreement with EPIC Engineering and Consulting Group, LLC for FY 2024 CAD, GIS, BIM and Related Services, as outlined in the memorandum.

SMALL BUSINESS

EPIC Engineering and Consulting Group, LLC is a certified Minority and Women Business Enterprise (MWBE)/Local Developing Business (LDB) firm. The Aviation Authority has reviewed the proposal from EPIC Engineering and Consulting Group, LLC, and determined that, due to the onsite staffing support services, EPIC Engineering and Consulting Group, LLC does not propose any MWBE/LDB/VBE participation on this addendum, and certifies that EPIC Engineering and Consulting Group, LLC is in good standing as it relates to its small business participation.
