Re: Request for Approval of an Addendum to the Information Technology Consulting Services Agreement with the Faith Group Consulting LLC for Building Management System Integration to Maximo, utilizing Contingency funds to supplement the purchase from W-S00145 South Terminal C, Phase 1-Owner Furnished FF&E and IT Items at the Orlando International Airport

On February 19, 2020, the Aviation Authority Board approved the Construction Committee's recommendation from February 4, 2020 CCM for the Estimated Budget for the STC P1 & P1X FF&E and IT Procurement. The "750" line item list included in the approval package reflected the FF&E and IT line items and estimates. Additionally, on June 23, 2020, the Construction Committee was advised via an Information Item, that in any case, if the actual procurement is 5% or more over the "Estimated Totals P1 and P1X" Column, re-approval will be obtained from the Committee for the use of Contingency Funds.

The scope of work for this Addendum is to build an interface to import data from the BMS to trigger maintenance on HVAC assets in Maximo.

If approved, these services would became effective upon execution of the Addendum.

The MWBE/LDB participation has been reviewed by the Office of Small Business Development. The Memo of findings and recommendation is attached.

The cost proposed by Faith Group Consulting LLC for this Addendum is \$61,916.00. Based on the Passenger Capacity Split, 72.73% of this fee (\$45,031.51) is to be funded from P1 and 27.27% (\$16,884.49) is to be funded from P1X.

The funds for this Addendum were included under W-S00145, Line 467 for the P1 portion, and funds from P1X Contingency are requested to cover the P1X portion.

The item details, quantities and pricing are shown on the "W-S00145 Construction Committee - Contingency Fund Use Approval Worksheet".



OBJECTIVE & OVERVIEW

Background

As part of the Faith Group (FG) Team, Starboard Consulting LLC, has been tasked with providing consulting services related to the integration of the Building Management System (BMS) with the Maximo Asset Management system for the Greater Orlando Aviation Authority (The Aviation Authority, TAA).

Faith Group will provide contract management, invoicing, and resource management of the Starboard efforts. Starboard's specific tasks and scope are detailed in their attached proposal and summarized within the Scope of Services below.

This estimate is made for The Aviation Authority ("TAA") by Starboard Consulting, LLC ("Starboard"). No work will be performed for this estimate until the work is authorized by TAA, and a Purchase Order is distributed to Starboard.

Brief Description of Request

TAA utilizes IBM Maximo Asset Management for managing work and asset management. Within Maximo, maintenance activities can be triggered from measurements and readings that are imported from an external system. This estimate is to build an interface to import data from the Schneider Building Management System (BMS) to trigger maintenance on HVAC assets in Maximo.

Detailed Description of Change

Starboard will work with TAAIT and Schneider to develop an interface to import data from the BMS to Maximo. This will be a one-way interface to acquire data from the BMS and write it to the Maximo tables to store meter and measurement data. Starboard will also work with TAA maintenance to identify the needed PM, job plan and condition monitoring records to establish the Maximo response to imported data that creates work orders for maintenance.

Starboard will perform the following project tasks as part of this effort:

- 1. Project Management and Oversight
- 2. Finalize integration requirements and data mapping
- Create integration objects and service for importing meters
 Assumption: this will use a web service or REST API, depending on the capabilities of the
 BMS. Starboard assumes any network connectivity or other infrastructure issues will be managed
 by TAA's IT team.
- Maximo data development to support integration
 Assumption: A cross reference between BMS and Maximo asset data can be established, and TAA will provide data load sheets in a Starboard provided template.
- 5. Support user acceptance testing
- 6. Conduct admin training to TAA maintenance admin and IT on the integration
- 7. Production Cutover and Go-Live Support

Project Specific Tasks

1. Project Management

Starboard will provide project management oversight to assist TAA's project manager with the development of the project schedule, scope definition, and financial reporting via regular communications, as needed.

Deliverables:

- Ad Hoc Status Updates
- Monthly Invoicing
- Project Change Requests (as needed)
- Project Schedule, collaboratively developed with TAA's representatives

2. Integration Requirement Meetings

Starboard will meet with the TAA Maintenance users and representatives from IT to refine the integration requirements for this project. Starboard has previously met with TAA to identify the high-level objectives; remaining meetings will cover the detailed design of field level mapping, interface connectivity and timing, data development needs for follow up maintenance programs, and how the BMS asset data will be referenced to Maximo asset records. Starboard will document the outcomes of these sessions in decision memos or integration design documents as appropriate.

Deliverables:

- Meeting Minutes
- Decision Memo or Integration Design (as needed)

3. Maximo Integration Development

Starboard will build the Maximo configuration objects needed to support importing the BMS data to Maximo. All configurations will be made using the delivered Maximo Integration Framework (MIF) tools and the Platform Configuration tools. Starboard expects that some additional database fields or indexes and automation scripts may be required to map data elements and provide any processing logic that may not be achievable via the MIF.

Starboard will build the integration in the Development environment for unit testing and initial validation. The configurations will be migrated to the Test environment for end-to-end system testing and user acceptance. Once approved, changes will be migrated to the Production environment.

Starboard will document any Maximo configurations made and produce an Integration Configuration report that includes the configurations made in Maximo to support the interface. Starboard will support TAA IT team in developing any change control documents needed.

Deliverable:

- Integration Configuration report
- Maximo migration packages

Assumptions:

- All configurations will be done using IBM delivered configurations tools; no java customizations will be required.
- It will be the responsibility of the BMS system provider to deliver an export of data from the BMS for Maximo to consume. Starboard assumes this will be a "push" interface where the data will be published from the BMS using a web service or REST API for Maximo to consume.
- Starboard assumes that any processing logic related to the data will be managed in the BMS to limit the data exchange to relevant meter and alarm points that are actionable within the Maximo system; routine readings and monitoring that does not indicate a maintenance issue will not be interfaced.

4. Data Development

Starboard will work with TAA Maintenance team to develop a maintenance response plan for the incoming meter data. Responses are expected to be work orders generated against the asset using the Condition Monitoring or PM capability of Maximo. Once the needed maintenance activities are identified, Starboard will work with Maintenance to populate data load templates for import to Maximo.

Asset data in Maximo will be reviewed and cross checked against available information in the BMS to establish a link between the record sets. This will ensure that meter data coming in from the BMS is probably tied to the correct asset record in Maximo. This link may be established by storing a BMS identifier in the Maximo Asset Tag field, adding an asset Alias value that ties to a BMS record, in a configured field specific to the BMS identifier, or using another method deemed suitable to support the Maximo user community and integration. Starboard assumes any updates needed to the asset data in Maximo can be managed via a data import; any updates needed on the BMS will be implemented by StarkTech.

Starboard will build the needed data to support the interface and import the provided data load templates. Data is expected to include meters, meter groups, asset updates, new PM or job plan records, and condition monitoring points. Each data set will be loaded in the Development environment for initial review, the Test environment for acceptance testing, and then Production. Data imports will be done using the MIF using flat file imports or manual entry.

5. Testing Support

Starboard will support Unit Testing, End-to-End Testing with the TAA IT team, and User Acceptance Testing (UAT) by the TAA Maintenance and IT teams. Starboard will monitor the testing log and work to resolve any reported defects. UAT will be performed in the Test Maximo environment and verify the integration is working as designed. Testing will include both the inbound meter data and the follow up work generation.

Assumptions:

TAA will develop all test scripts to be used during UAT with support from Starboard.

6. End-User and Admin Training

Starboard will provide training for the Maximo Administrators and TAA IT for managing the interface and updating asset data as assets are replaced. Training will include an overview of the interface configuration and tips on troubleshooting any integration errors, as well as instruction on any changes to the asset replacement process in Maximo so that new assets retain their link to the correct BMS record.

Deliverable:

• Training Materials

Assumptions:

- Admin and IT training will be delivered onsite using a TAA environment.
- TAA will coordinate training dates and provide a training room with workstations for each student and an instructor workstation with projection capabilities.

7. Production Cutover

Starboard will work with the TAA IT team to schedule and execute the production cutover for this project. Starboard will use the migration to the Test environment as a "mock" cutover to verify that all configurations and data updates are properly documented and to identify the needed cutover schedule. The production cutover will follow TAA IT change management policies and procedures and be set at a time mutually agreed by Starboard and TAA.

Post go-live Starboard will provide remote support to the TAA maintenance and IT teams on an as needed basis to address any issues that may arise in the first 10 days of using the interface. During this time, Starboard will answer any questions from the users, provide additional coaching, and assess and resolve any defects found. Any new requirements introduced will be placed on an enhancement list for prioritization with other TAA Maximo initiatives.

Deliverable:

• Go-Live Checklist

TAA Responsibilities

- TAA will lead and perform all required User Acceptance Testing activities.
- TAA will schedule personnel and locations for End User training activities as required.

Assumptions

- TAA will provide remote access for Starboard to the Maximo applications, databases, and servers for this effort.
- Starboard will perform development activities off site and provide TAA configuration documents for change control.

- Starboard will perform changes in the DEV environment where they will be unit tested. Once successfully validated, the changes will be applied to TEST and user tested by TAA. Once approved, the updates will be applied to PROD as part of a scheduled release.
- This project scope is priced and based entirely on the information and the requirements provided by TAA. If any variances are determined by Starboard or requested by TAA, a change order for adjustment to scope, schedule, or cost will be submitted.
- Starboard cannot be held responsible for any defects in the Maximo applications as delivered from the vendor, IBM. If any defects are found, Starboard will open a PMR with IBM support and Starboard will work with TAA IT staff as needed with obtaining log files and communicating findings to the L1 or L2 IBM support personnel. If necessary for Starboard to install an IBM delivered fix, create a work around process, or develop a TAA specific solution to an IBM defect, a PCR will be created to address the change.

Invoicing

The following tables show the estimated costs for this Time and Materials effort. TAA will be invoiced monthly for the previous month's work and the payment expectation is net 30. Starboard estimates that this project will be supported remotely, but local resources will be used for any on-site needs so that no expenses will be incurred.
