DESCRIPTION OF CHANGE:

- 1. Provide all labor, equipment and materials to:
- a. Add one stop sign with pole at the Parking Lot Exit, at the three-way intersection, where the stop bar is located:
- b. Add one stop sign with pole at the Parking Lot Entrance, at the three-way intersection, where the stop bar is located;
- c. Add three "Do Not Enter / Employee Parking Only" signs at entrance, one with left arrow. Mount these signs to the existing sign posts;
 - d. Add one aluminum "Employee Exit" sign on the aluminum canopy structure;
 - e. Mount the Owner-provided red/white fiberglass reflector strips on stop signs, road signs and fence gates;
- f. Add twelve End of Roadway Markers, Red, OM4-1, and mount to the six double-swing gates, so that the signs face to oncoming traffic;
- g. Add one sign with an arrow pointing straight ahead with the work "ONLY" at the stop sign inside the Employee guard shack entrance;
- h. Add one painted white arrow on the asphalt at the stop bar just inside the Employee guard shack entrance, pointing straight ahead;
 - i. Stencil "Compact Car Only" at each parking space to the right side of the bus exit lane, for 24 parking spaces;
- j. Add one Building number sign, 30"x14" aluminum, adhered with double-sided tape. Building number is "1077 Security Checkpoint";
 - k. Add one restroom sign inside guard shack; and,
 - I. Add eight metal door tags, 4.5"x1-3/4", on the door frames of the guard shack doors.

This change order replaced Field Change Order No. 24. (Reference Contractor's PCO No. 44). ADD: \$8,711.34

2. Provide all labor, material and equipment to install two 3/4"x10' copper ground rods, clamps and cables to the gate posts for grounding of the personnel gate at the OUC water valve locations. (Reference Contractor's PCO No. 47). ADD: \$948.75
