## **DESCRIPTION OF CHANGE:**

Provide all material, labor, and equipment necessary to perform underground sanitary utility work in accordance with the response to RFI 0112 and 0112.1. This proposal's scope of work is for the BP-S00195-MCO civil contractor to excavate, investigate and connect the building's sanitary laterals to the main distribution lateral stubups with a minimum slope, and to install clean-outs with 5-feet of the building in accordance with Authority Having Jurisdiction (AHJ) engineering standards, details, and documents in accordance the RFI response. This Change Order Request includes all costs for material, labor, and equipment impacting the BP-S00195-MCO project associated with RFIs 0112 and 0112.1 Existing Underground Sanitary Lateral Point of Connection.

This change order's scope of work assumes no modifications to the Campus' Sanitary Main Distribution System are required. If any modifications are required based on the conclusions of the existing conditions' investigations, direction from the Owner with revised contract drawings by the design team will be required to re-evaluate the cost and schedule impacts. ADD: \$62,364.00
