DESCRIPTION OF CHANGE:

- 1. Provide all labor, equipment, and materials to increase the size of the two Airside 4 canopy fingers from 14'9" x 8'9" x 10'0" to 22'6" x 8'9" x 10'9", and a credit for the decrease in size of the Airside 4 main canopy from 20'3" x 102'0" x 10'0" to 20'3" x 100'10" x 10'0". ADD: \$7,233.67
- 2. Provide all engineering and design costs for signed and sealed drawings as required by the City of Orlando. ADD: \$10,450.00
- 3. Reduce the AE Permit Drawing allowance from \$15,000.00 to \$4,550.00 to offset the cost associated with Signed and Sealed Drawings in Item No. 2 above. DEDUCT: (\$10,450.00)
- 4. Provide all labor, equipment, materials, and supervision to install 316 LF of 12' high black vinyl chain link fencing to include two 8'-high x 6'-wide rolling gates and one 8'-high x 4'-wing single swing gate. Fencing shall be installed around the perimeter of the newly installed canopy. All gaps between the fence posts and the existing building structure shall be in-filled with stationary panels. ADD: \$47,856.60
- 5. Provide all labor, equipment, materials, and supervision to install approximately 500 SF of Armstrong VCT Flooring (Imperial Texture 51858 Sandrift White) and approximately 130 LF of Johnsonite Traditional Wall Base (09 Clay WB) within the newly constructed hold rooms in the Airside 4 Hub, Ramp Level. Also included shall be the removal of the existing carpet flooring and wall base. Floors shall be prepped in accordance with the VCT Flooring manufacturer's recommendations. This Change Order replaces Field Change Order No 1. ADD: \$7,045.50
- 6. Reduce the Airside 4 Interior Renovations allowance from \$65,000.00 to \$57,954.50 to offset the costs associated with Item No. 5 above. DEDUCT: (\$7,045.50)
