Provide all labor, material and equipment to furnish, install and label two APC 9560 Power Distribution Units (PDU) in the tenant communications cabinet in Room 01.5697, convert the two existing power outlets in Room 01.5697 from 208V to 120V with 30A twist lock receptacles, relocate one existing communications cabinet from Room 02.4226 and mount in Room 01.5697, ground the tenant cabinet, Cat 6 and fiber patch cables for the tenant cabinet, install wiremold and Cat 6 patch cables to two tenant FIDS monitors, and provide eight hours stand-by time throughout the night of the airline relocation. This change order replaces Field Change Order No. 1. ADD: \$5,106.60

2. Provide all labor, material, and equipment to install seven new power circuits with 12-quad receptacles, at STC LST Rooms 01.6561, 01.6581, 01.6597, 01.6606, and 01.6741, to include patching and painting of existing walls. ADD: \$20,261.16
