On January 24, 2023, the Construction Committee approved Addendum No. 46 for \$84,702.00 to the above referenced agreement for services for H-S00029 Airfield Civil Restart Enabling Work. On February 21, 2023, the Construction Committee approved Amendment 1 to Addendum 46 in the amount of \$102,701.50 for additional construction administration services.

Since that time it has been determined that additional services are required for surveying of existing conditions to support the project.
