

**ADDENDUM NO. 47 TO AGREEMENT
DATED DECEMBER 10, 2015, BETWEEN
THE GREATER ORLANDO AVIATION AUTHORITY
AND HNTB CORPORATION**

Project: **Design Modifications for Changing Regulatory Requirements Program for W-S110 South Terminal C, Phase 1 - Architect of Record Services, Orlando International Airport**

THIS ADDENDUM is effective as of this 11th day of April, 2023, by and between the **GREATER ORLANDO AVIATION AUTHORITY** ("Authority") and **HNTB CORPORATION** ("Consultant").

WITNESSETH

WHEREAS, by Agreement dated December 10, 2015, Authority and Consultant entered into an Agreement for Consultant to provide Architect of Record for the South Terminal C, Phase I services; and

WHEREAS, under the Agreement, Consultant agreed to perform such additional professional services for Authority as are contained in any additional scope of work established by Authority in any Addendum to the Agreement and accepted in writing by Consultant; and

WHEREAS, Authority and Consultant desire to enter into this Addendum to the Agreement to provide for additional services to be rendered by Consultant under the terms of said Agreement.

NOW, THEREFORE, in consideration of the premises and the mutual covenants herein contained, Authority and Consultant do hereby agree as follows:

1. Consultant shall perform additional services in accordance with the terms of the Agreement and the attached Exhibit "A." Consultant shall be paid for such additional services according to the payment terms set forth in the Agreement.

2. Consultant shall be compensated for such additional services in the **LUMP SUM AND NOT TO EXCEED amount of ONE HUNDRED SEVENTY-SEVEN THOUSAND TWO HUNDRED FORTY-SIX AND NO/100 DOLLARS (\$177,246.00)**, broken down as follows:

3. A. Consultant hereby certifies that it is not on the Scrutinized Companies that Boycott Israel List and is not engaged in a boycott of Israel, as defined in Florida Statutes § 287.135, as amended;

AND

B. (applicable to agreements that may be \$1,000,000 or more) - Consultant hereby certifies that it is: (1) not on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List as defined in Florida Statutes § 287.135; and (2) not engaged in business operations in Cuba or Syria, as defined in Florida Statutes § 287.135, as amended.

4. Authority may terminate the Agreement for cause and without the opportunity to cure if the Consultant is found to have submitted a false certification or has been placed on the Scrutinized Companies that Boycott Israel List or is engaged in a boycott of Israel.

In the event the Agreement is for One Million Dollars (\$1,000,000.00) or more, Authority may terminate this Agreement for cause and without the opportunity to cure if the Consultant is found to have submitted a false certification or has been placed on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List or is engaged in business operations in Cuba or Syria.

5. Except as expressly modified in this Addendum, the Agreement dated December 10, 2015 and all prior addenda will remain in full force and effect.

Re: Request for Approval of an Addendum to the Architect of Record for South Terminal C, Phase 1, Agreement with HNTB Corporation for design modifications for Changing Regulatory Requirements Program for W-S00110, Terminal C, Phase 1 – Architect of Record (and Major Subconsultants), at the Orlando International Airport

Consultant's proposal, dated April 3, 2023, is to provide additional design services from the HNTB team for interagency coordination and support of providing the required workspace and infrastructure at the STC. This work consists of modifying spaces under regulatory control, including CBP, TSA, and other spaces as needed to meet changing regulatory requirements or regulatory agency requests. This includes, but is not limited to, new staff restrooms, breakroom, door modifications, FIS glare at podiums, and exterior improvements at CBP parking lot.

If approved, these services would be effective April 11, 2023.

Consultant shall, with each monthly invoice, certify that the assigned work and services are on schedule to be completed within the contracted lump sum price, or provide at time of certification a written notice to the Authority of any deviations.

The MWBE/LDB participation has been reviewed by the Office of Small Business Development. Their findings and recommendation are attached.

Funding is from General Airport Revenue Bonds, Customer Facility Charges, Passenger Facility Charges (PFC's) to the extent eligible. Funding source verified by Malvin Martinez of Construction Finance on 04 / 07 / 23 as correct and available.

It is respectfully requested that the Construction Committee approve an Addendum to the Architect of Record Services for the South Terminal C, Phase 1 Agreement with HNTB Corporation for the services contained herein and amount as shown below:

Dear Mr. Shedek:

As requested, HNTB Corporation ("HNTB") is submitting this proposal to provide design services for the following modifications as requested by GOAA in consultation with the new CBP Port Director:

SCOPE OF WORK:

Since opening Terminal C, CBP staff has gained operational experience in the facility and has requested several additional changes for their convenience. The design team has been requested to provide separate design costs for each item described below, which will each require schematic layout for approval and then the completion of final designer's supplemental instruction (DSI) documents:

1. Level 6:

- a. Create Men's and Women's Restrooms in one of the Voluntary removal suites
 - i. Existing Chase- review most efficient layout
 - ii. Men's- one toilet and one urinal + lav
 - iii. Women's- two toilets + lav
 - iv. ADA- these restrooms are for CBP staff only- CBP requests 1stall each to meet ADA
- b. Breakroom
 - i. Add sink (with hot water) and base cabinet; garbage disposal (review- back wall or best location based on utilities)- include large commercial fridge and microwave
 - ii. Add monitors- 3- similar to Level 1 Breakroom- fed from overhead- power and data required
 - iii. Return air
 - iv. Potential to add 5 circuits
- c. Door to Elevator to Ramp- at new lounge-
 - i. CBP ACS only
- d. Lift access- at Bag cart at TSA Screening
 - i. Lift document with dimensions
 - ii. Roll up doors possibly with two heights
- e. Podiums- Develop sun glare solution at the podiums for the officers' eyes and for the monitors to reduce monitor glare

2. Level 1: Add a concrete patio inside the CBP fenced parking area

As discussed with Authority and the OAR staff, these services will revise the existing Phase 1 building plans for these changes to produce a DSI and permit review documents. The DSI documents will be transmitted for GOAA / OAR use in preparing change orders to the Authority contractor.



In addition to the HNTB design team staff, HNTB will work with original LST design team major subconsultants Matern Professional Engineering and Syska Hennessey Group for these services.

SCHEDULE:

From receipt of notice to proceed, the design services would carry through the GOAA / OAR issuance of change order documents to the contractor.

FEE:

As discussed in our meeting on 3/21/23, it is proposed to fund these WS110 design services from regulatory funds. The design will require use of our lump sum staff and our not-to-exceed design support staff, summarized as follows and broken down as requested by project.
