#### **AMENDMENT NO. 4**

#### BY AND BETWEEN

# GREATER ORLANDO AVIATION AUTHORITY AND HOME PARAMOUNT PEST CONTROL COMPANY

#### **PURCHASING CONTRACT 08-19**

THIS AMENDMENT NO. 4 made and entered into as of the <u>26th</u> day of <u>May</u>, 2023 by and between the GREATER ORLANDO AVIATION AUTHORITY (hereinafter referred to as "Aviation Authority") and HOME PARAMOUNT PEST CONTROL COMPANY (hereinafter referred to as the "Contractor").

#### WITNESSETH:

WHEREAS, by Contract dated July 1, 2019, and as amended by Amendment No. 1 dated September 30, 2019, Amendment No. 2 dated November 5, 2020, and Amendment No.3 dated May 25, 2022, Contractor agreed to perform pest control services at Orlando International Airport, Orlando, Florida; and

WHEREAS, the Contract provides the Aviation Authority with options to renew the term of the Contract for two (2) additional periods of one (1) year each; and

WHEREAS, the Aviation Authority desires to exercise its second option to renew the term of the Contract for an additional period of (1) year; and

WHEREAS, the Aviation Authority and Contractor agrees to adjust the Contract to: Add Six (6) locations on the Orlando International Airport Terminal C as described in Attachment "F" and change the name of South Terminal Locations as described in Attachment "C" to The Train Station.

WHEREAS, the Aviation Authority requires the Contractor's prior written consent, which the Aviation Authority is willing to give based on the terms and conditions set forth below.

**NOW**, **THEREFORE**, for and in consideration of the premises and mutual covenants herein contained, the parties hereby amend the Contract as follows:

- 1. Renewal Term of the Contract. The term of the Contract shall be, and hereby is renewed and extended for a period of one (1) year, commencing effective as July1, 2023 and expiring June 30, 2024.
- **2.** <u>Contract Adjustment</u>. The Aviation Authority's Attachments "C" And "F" and the Bid Prices table (Exhibit "A-4") shall be amended to (i) add the Standard Hours and Non-Standard Hours prices for Terminal C to the Bid Prices Form; (ii) Change the name from South Terminal Locations to The Train Station on Attachment "C". Attachment "C" And "F" are attached to this Amendment and incorporated in the Amendment for reference.
- 3. <u>Compensation</u>. Authority shall pay to the Contractor during the renewal term of the Contract, upon satisfactory completion of work required by the provisions of the Contract, the Unit Prices as shown on Attachment "A-4", Second Renewal Option Prices. Compensation shall be paid pursuant to the terms and conditions of the Contract.

- 4. <u>Contractor's Performance Bond or Letter of Credit</u>. Upon execution of this Amendment No.4, Contractor shall furnish the Aviation Authority with a replacement bond or duly executed rider or other acceptable form of amendment to Contractor's performance bond or Letter of Credit for the extended term in an amount, which is not less than Forty-Three Thousand and Three-Hundred Dollars (\$43,300.00) shall remain the same as the terms and conditions of the Contract.
- **5.** Public Entity Crimes Act. The Contractor acknowledges the following notice: "A person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a contract to provide any goods or services to a public entity, may not submit a bid on a contract with a public entity for the construction or repair of a public building or public work, may not submit bids on leases of real property to a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount set forth in s.287.017, Florida Statutes, for CATEGORY TWO for a period of thirty-six (36) months from the date of being placed on the convicted vendor list."
- **6.** Continuing Effect of Contract Provisions. Except as amended by this Amendment No. 4, the Contract shall continue in full force and effect in accordance with its terms and conditions.
