**WHEREAS**, under the Agreement, Consultant agreed to perform such additional services for the Authority as are contained in any additional scope of work established by the Authority in any addendum to the Agreement and accepted in writing by the Consultant; and

**WHEREAS**, the Authority and the Consultant desire to enter into this Addendum to the Agreement to provide for additional services to be rendered by the Consultant under the terms of said Agreement.

**NOW, THEREFORE**, in consideration of the premises and the mutual covenants herein contained, the Authority and the Consultant do hereby agree as follows:

- 1. Consultant shall perform additional services in accordance with the terms of the Agreement and the attached Exhibit "A." Consultant shall be paid for such additional services according to the payment terms set forth in the Agreement.
- 2. Consultant shall be compensated for such additional services in the **NOT TO EXCEED** amount of **NINETY-NINE THOUSAND NINE HUNDRED FORTY-SIX AND NO/100 DOLLARS (\$99,946.00)**, broken down as follows:

 A. Consultant hereby certifies that it is not on the Scrutinized Companies that Boycott Israel List and is not engaged in a boycott of Israel, as defined in Florida Statutes § 287.135, as amended; AND

- B. (applicable to agreements that may be \$1,000,000 or more) Consultant hereby certifies that it is: (1) not on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List as defined in Florida Statutes § 287.135; and (2) not engaged in business operations in Cuba or Syria, as defined in Florida Statutes § 287.135, as amended.
- 4. Authority may terminate the Agreement for cause and without the opportunity to cure if the Consultant is found to have submitted a false certification or has been placed on the Scrutinized Companies that Boycott Israel List or is engaged in a boycott of Israel.

In the event the Agreement is for One Million Dollars (\$1,000,000.00) or more, Authority may terminate this Agreement for cause and without the opportunity to cure if the Consultant is found to have submitted a false certification or has been placed on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List or is engaged in business operations in Cuba or Syria.

5. Except as expressly modified in this Addendum, the Agreement dated September 8, 2017 and all prior addenda will remain in full force and effect.

### ITEM DESCRIPTION

Request for Recommendation to the Aviation Authority Board Approval of an Addendum to the Continuing MEP Engineering Services Agreement with Matern Professional Engineering, Inc. (MPE) to provide fiscal year 2024 (FY24) On-Call Mechanical, Electrical and Plumbing Engineering Services at the Orlando International Airport.

## **BACKGROUND**

In 2017, the firms providing Continuing Mechanical, Electrical and Plumbing (MEP) Engineering Services were selected through a competitive award process. These services are procured on an as-needed or annual basis.

On August 16, 2017, the Aviation Authority Board approved a Continuing MEP Engineering Services Agreement with the following firms:

- Matern Professional Engineering, Inc.
- C&S Engineers, Inc.
- SGM Engineering, Inc.
- RTM Engineering Consultants, LLC
- Graef-USA, Inc.

These no-cost base agreements established the negotiated hourly rates. The services may include the performance of MEP engineering and related professional services, including, but are not limited to, mechanical, electrical and plumbing design; fire protection engineering; security and systems design; structural design; utility and infrastructure cost estimating; scheduling and any associated architecture and all other related services including coordination with the Aviation Authority, its consultants, the City of Orlando and all agencies having jurisdiction over the Orlando International and Orlando Executive Airports. The services may also include studies and preparation of reports involving scope definition and validation of projects, analysis of design parameters, budget development, evaluation and documentation of existing conditions; design, bid/procurement and award, design/build, permitting, documents prepared by others, design management support on various Aviation Authority projects and all other engineering and related professional services which may be required where the Aviation Authority elects not to solicit letters of interest by means of public advertisement.

On January 18, 2023, the Aviation Authority Board approved exercising an additional renewal option and extending the Continuing MEP Engineering Consulting Services Agreement with MPE to September 30,

2023. This extension was necessary to maintain coverage of these MEP services while the Aviation Authority continues its evaluation regarding continuing agreement alternatives.

## **ISSUES**

Consultant's proposal, dated August 24, 2023, is to provide FY24 On-Call MEP engineering consulting services to the Greater Orlando Aviation Authority.

The cumulative contract value of all addenda/amendments since the last approval by the Aviation Authority Board to the Continuing MEP Engineering Services Agreement with Matern Professional Engineering, Inc. (MPE) exceeds the \$250,000 threshold; thus, this agenda item requires Board approval.

If approved, these services would be effective October 1, 2023 and extend through September 30, 2024.

# **SMALL BUSINESS**

The MWBE/LDB/VBE participation has been reviewed by the Office of Small Business Development (OSBD). The findings and recommendation are attached.

#### **ALTERNATIVES**

None.

## **FISCAL IMPACT**

The fiscal impact is \$99,946.00 from FY24 Operation and Maintenance (O&M) Funds, subject to adoption by the Aviation Authority Board of the FY24 Aviation Authority budget.



Recommendation of the Procurement Committee to Approve an Addendum to the Continuing Mechanical, Electrical, Plumbing (MEP) Engineering Services Agreement with Matern Professional Engineering, Inc. for FY 2024 On-Call MEP Engineering Services, at the Orlando International Airport

#### **BACKGROUND**

On August 16, 2017, the Aviation Authority Board approved Continuing MEP Engineering Consulting Services Agreements with the following firms, following a competitive award process in compliance with state statutes and Aviation Authority policies:

- C&S Engineers, Inc.
- · Graef-USA, Inc.
- Matern Professional Engineering, Inc.
- RTM Engineering Consultants, LLC (MWBE)
- SGM Engineering, Inc. (MWBE/LDB)

The agreements are structured as a no-cost base agreement with negotiated hourly rates. Services that are within the advertised scope are negotiated on an as-needed or annual basis, and awarded as addenda to the base agreement. The terms of the agreements shall be for a period of three years with optional renewal periods of two additional one-year terms, to be exercised at the discretion of the Aviation Authority and accepted by both parties. On January 18, 2023, the Aviation Authority Board approved an addendum to each agreement exercising an additional renewal option through September 30, 2023.

Services may include, but are not limited to, mechanical, electrical and plumbing design; fire protection engineering; security and systems design; structural design; utility and infrastructure cost estimating; scheduling and any associated architecture and all other related services including coordination with the Aviation Authority, its consultants, the City of Orlando and all agencies having jurisdiction over the Orlando International Airport, Orlando Executive Airport, and other facilities operated by the Aviation Authority. The services may also include studies and preparation of reports involving scope definition and validation of projects, analysis of design parameters, budget development, evaluation and documentation of existing conditions; design, bid/procurement and award, design/build, permitting, documents prepared by others, design management support on various Aviation Authority projects, and all other engineering and related professional services.

A total of 28 addenda, and applicable amendments, to the Continuing MEP Engineering Services Agreement with Matern Professional Engineering, Inc. have been approved. A summary of these approvals can be provided upon request.

#### **ISSUES**

Per the Aviation Authority's Policy 450.04, the Aviation Authority Board must approve all contract addenda and applicable amendments that result in the value of any contract being increased, in the aggregate, by \$250,000 or more over the contract value.

On September 12, 2023, the Procurement Committee recommended approval of an addendum to the Continuing MEP Engineering Services Agreement with Matern Professional Engineering, Inc. as follows:

• Addendum for FY 2024 On-Call MEP Engineering Services, at the Orlando International Airport, for the total not-to-exceed fee amount of \$99,946, with funding from Operations and Maintenance Funds (subject to adoption of the FY 2024 Aviation Authority Budget by the Aviation Authority Board under separate item). Services will consist of MEP design; fire protection engineering; security and systems design; structural design; utility and infrastructure cost estimating; scheduling; other studies and related services regarding investigations, planning services, site selection services, relocation services document processing, testing services, and photographs; and, any associated architecture and all other related MEP services. Services will be provided from October 1, 2023, through September 30, 2024.

As this addendum will result in an aggregate increase to the Aviation Authority's Agreement Matern Professional Engineering, Inc. exceeding \$250,000, Aviation Authority Board approval is required, as outlined in the memorandum.

### **SMALL BUSINESS**

The Aviation Authority has reviewed the proposal from Matern Professional Engineering, Inc., and determined that Matern Professional Engineering, Inc. does not propose any small business participation on this Addendum because of the on-call nature of the services to be provided. The Small Business Department certifies that Matern Professional Engineering, Inc. is in good standing as it relates to its small business participation as required on previously contracted services.

The fiscal impact is \$99,946. Funding is from Operations and Maintenance Funds (subject to adoption of the FY 2024 Aviation Authority Budget by the Aviation Authority Board under separate item).

# **RECOMMENDED ACTION**

It is respectfully requested that the Aviation Authority Board resolve to accept the recommendation of the Procurement Committee and approve an Addendum to Continuing MEP Engineering Services Agreement with Matern Professional Engineering, Inc. for FY 2024 On-Call MEP Engineering Services, at the Orlando International Airport, for the total not-to-exceed fee amount of \$99,946, with funding from Operations and Maintenance Funds; and, authorize an Aviation Authority Officer or the Chief Executive Officer to execute the necessary documents following satisfactory review by legal counsel.
