Request for Recommendation of Approval of an Amendment to Addendum 24 to the Continuing MEP Engineering Consultant Services Agreement with Matern Professional Engineering, Inc. (MPE) to provide Additional FY2023 On-Call Mechanical, Electrical and Plumbing System Review and Master One-Line Diagram Update Services at the Orlando International Airport

### **BACKGROUND**

In 2017, the firms providing Continuing Mechanical, Electrical and Plumbing (MEP) Engineering Services were selected through a competitive award process. These services are procured on an as-needed or annual basis.

On August 16, 2017, the Aviation Authority Board approved a Continuing MEP Engineering Consultant Services Agreement with the following firms:

- Matern Professional Engineering, Inc.
- C&S Engineers, Inc.
- SGM Engineering, Inc.
- RTM Engineering Consultants, LLC
- Graef-USA, Inc.

These no-cost base agreements established the negotiated hourly rates. The services may include the performance of MEP engineering and related professional services, including, but are not limited to, mechanical, electrical and plumbing design; fire protection engineering; security and systems design; structural design; utility and infrastructure cost estimating; scheduling and any associated architecture and all other related services including coordination with the Aviation Authority, its consultants, the City of Orlando and all agencies having jurisdiction over the Orlando International and Orlando Executive Airports. The services may also include studies and preparation of reports involving scope definition and validation of projects, analysis of design parameters, budget development, evaluation and documentation of existing conditions; design, bid/procurement and award, design/build, permitting, documents prepared by others, design management support on various Aviation Authority projects and all other engineering and related professional services which may be required where the Aviation Authority elects not to solicit letters of interest by means of public advertisement.

### **ISSUES**

On September 27, 2022, the Construction Committee approved Addendum 24 in the amount of \$50,000.00 to the above-referenced agreement. Since that time, it has been discovered that additional on-call services are required by the various departments, as furthered described in Consultant's proposal, dated February 1, 2023. It is recommended that a performance bond not be required for these since these are on-call professional services.

If approved, these services would be effective the date of Aviation Authority Board approval.

The MWBE/LDB/VBE participation has been reviewed by the Office of Small Business Development (OSBD). The findings and recommendation are attached.

On August 16, 2017, the Aviation Authority Board approved a Continuing MEP Engineering Consulting Services Agreement with the following firms:

- Graef-USA, Inc.
- · Matern Professional Engineering, Inc.
- RTM Engineering Consultants, LLC (MWBE)
- SGM Engineering, Inc. (MWBE/LDB)

These no-cost base agreements established the negotiated hourly rates. The services may include the performance of MEP engineering and related professional services, including, but are not limited to, mechanical, electrical and plumbing design; fire protection engineering; security and systems design; structural design; utility and infrastructure cost estimating; scheduling and any associated architecture and all other related services including coordination with the Aviation Authority, its consultants, the City of Orlando and all agencies having jurisdiction over the Orlando International and Orlando Executive Airports. The services may also include studies and preparation of reports involving scope definition and validation of projects, analysis of design parameters, budget development, evaluation and documentation of existing conditions; design, bid/procurement and award, design/build, permitting, documents prepared by others, design management support on various Aviation Authority projects and all other engineering and related professional services which may be required where the Aviation Authority elects not to solicit letters of interest by means of public advertisement.

Addenda Nos. 1 through 25, and applicable amendments, to the Continuing MEP Engineering Consulting Services Agreement with Matern Professional Engineering, Inc. have been approved by the Construction Committee. A summary of these approvals is provided as an attachment to this memorandum.

Since January 1, 2023, non-project specific services are now submitted to the Procurement Committee (PC) for approval. Per the Aviation Authority's Policy 450.04, the Aviation Authority Board must approve

all agreement addenda and applicable amendments that result in the value of any agreement being increased, in the aggregate, by \$250,000 or more over the agreement value.

### **ISSUES**

A fee has been negotiated for an Amendment to Addendum No. 24 to the Continuing MEP Engineering Consulting Services Agreement with Matern Professional Engineering, Inc. for a total amount of \$59,940, to provide Additional On-Call MEP System Review and Master One-Line Diagram Update Services at the Orlando International Airport, as required by various Aviation Authority departments. These services include, but are not limited to, tenant project design reviews, responses to the Facilities Department requests for field assessments of existing conditions, permit plan development for Information Technology low voltage installations, assistance in the coordination of north and south terminal project electrical design services and installations, and other related services at the Orlando International Airport. Many small tenant and Aviation Authority projects require an assessment and design or scope review to ensure these projects are coordinated with existing electrical distribution systems. The additional scope of services includes, but is not limited to, an update to the Master One-Line Diagram for the North Terminal Complex following the completion of various electrical projects, and includes on-call coordination with the Facilities Electrical Systems Manager for electrical projects. Services will be provided through September 30, 2023.

On February 28, 2023, the Procurement Committee recommended approval of Amendment to Addendum No. 24 to the Continuing MEP Engineering Consulting Services Agreement with Matern Professional Engineering, Inc. for Additional FY 2023 On-Call MEP System Review and Master One-Line Diagram Update Services at the Orlando International Airport, as outlined in the memorandum.

As this amendment to Addendum No. 24 will result in an aggregate increase to the Aviation Authority's Agreement with Matern Professional Engineering, Inc. exceeding \$250,000, Aviation Authority Board approval is required.
