- 2. Consultant shall be compensated for such additional services in the **NOT TO EXCEED** amount of **ONE HUNDRED NINETY-FIVE THOUSANDTHREE HUNDRED THREE AND NO/100 DOLLARS (\$195,303.00)**, broken down as follows:

(applicable to agreements that may be \$1,000,000 or more) Consultant hereby certifies that it is: (1) not on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List as defined in Florida Statutes § 287.135; and (2) not engaged in business operations in Cuba or Svria, as defined in Florida Statutes § 287.135. as amended.
- Authority may terminate the Agreement for cause and without the opportunity to cure if the Consultant is found to have submitted a false certification or has been placed on the Scrutinized Companies that Boycott Israel List or is engaged in a boycott of Israel.

In the event the Agreement is for One Million Dollars (\$1,000,000.00) or more, Authority may terminate this Agreement for cause and without the opportunity to cure if the Consultant is found to have submitted a false certification or has been placed on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List or is engaged in business operations in Cuba or Syria.

Except as expressly modified in this Addendum, the Agreement dated January 8, 2021 and all prior addenda will remain in full force and effect.

Dear Mr. Shedek:

Ricondo & Associates, Inc. (Ricondo), Studio for Architecture, Inc., and KMI, Inc. appreciate the opportunity to submit this proposal to assist the Greater Orlando Aviation Authority (GOAA) with the preparation of a design criteria package for improvements to restrooms at Airsides 1, 2 and 3. The project is to include renovations to existing restrooms at Airsides 1, 2 and 3. The project will also include new restrooms at Airsides 1 and 3 near the Hub. As a part of our scope of work we have included a site visit for all 3 Airsides to review previously generated concepts and determine preferred concepts for each Airside. The basis for this proposal includes information sent to Ricondo in an email dated October 19, 2023 and is attached to this proposal letter. It is assumed that the project will be completed as one Design Criteria Package. Tasks to be performed by the Ricondo Team include:

- Collect information relevant to the project including, but not limited to, as-built drawings
- Identify and review applicable codes and standards and, as needed, consult with the Authority having jurisdiction
- Conduct a site visit for discovery and conditions assessment
- Assess Capacity of Existing Infrastructure:
- Mechanical: Assessment of the existing HVAC systems to determine their capacity to handle the additional load from the expanded areas. This includes evaluating air handling units, ductwork, and ventilation systems.
- Electrical: Review of the existing electrical distribution system, lighting, and power outlets. This will
  determine if the current system can support the added electrical loads or if upgrades are necessary.
- Plumbing: Examination of the existing plumbing infrastructure, including water supply, drainage, and waste systems. This will identify if the current plumbing can support the additional fixtures and increased water demand.
- Fire Protection: Evaluation of the existing fire alarm and sprinkler systems to ensure they can be extended to cover the expanded areas and meet all safety standards

- Refinement, Evaluation, and selection of a preferred concept for each airside:
- The restrooms improvements that were previously recommended will be refined, as needed, to incorporate recent improvements to the airsides and to incorporate new design ideas or recommendations.
- The options for each airside will be evaluated in terms of their ability to improve the customer experience, as well as potential impacts to passenger flows, etc. A set of evaluation criteria will be developed jointly by GOAA and the Ricondo Team for use in analyzing and evaluating each option selected for further evaluation during the initial screening. The Ricondo Team will compile this evaluation into a decision matrix for the Authority's review.
- Selection of a preferred option for each airside: one in-person workshop will be conducted with GOAA staff to review and evaluate the options to be developed for Airsides 1, 2, and 3.
- Identify constraints that may impact the project as it relates to applicable codes and standards
- Consideration of existing operations and GSE and other apron operations will be coordinated so that the proposed new restroom additions will not impact operations.
- Once the above noted workshop is completed and a preferred restroom design option is selected for each airside, an additional scope and fee will be submitted for a detailed cost estimate.
- Prepare design criteria in accordance with GOAA EDC-23
- In addition to the workshop, conduct up to five virtual meetings with GOAA engineering to discuss existing conditions, applicable codes and standards, and proposed design criteria

#### **Deliverable**

PowerPoint Presentation summarizing the refined restroom improvement options that were evaluated including evaluation criteria, cost estimates, etc. This presentation will also include the findings of the capacity assessment and other relevant information from the site visits.
