

AMENDMENT NO. 18

PURCHASING CONTRACT 23-05

THIS AMENDMENT NO. 18 made and entered into as of the December 1st, 2022, by and between the **GREATER ORLANDO AVIATION AUTHORITY** (hereinafter referred to as "Authority") and **SITA INFORMATION NETWORKING COMPUTING USA, INC.** (hereinafter referred to as "Contractor").

WITNESSETH:

WHEREAS, by Contract dated May 3, 2006, as amended by Amendment No. 1 dated May 3, 2006, Amendment No. 2 dated March 9, 2009, Amendment No. 3 dated December 11, 2009, Amendment No. 4 dated October 29, 2010, Amendment No. 5 dated December 22, 2011, Amendment No. 6 dated November 21, 2012, Amendment No. 7 dated November 1, 2013, Amendment No. 8 dated August 28, 2015, Amendment No. 9 dated August 19, 2015, Amendment No. 10 dated July 13, 2016, Amendment No. 11 dated April 5, 2017, Amendment No. 12 dated April 6, 2017, Amendment No. 13 dated July 23, 2019, Amendment No. 14 dated July 24, 2019, Amendment No. 15 dated December 31, 2019, Amendment No. 16 dated April 15, 2021, and Amendment No. 17 dated July 1, 2021, Contractor agreed to provide a Multi-Use Flight Information Display System Installation and Maintenance ("MUFID System") for the Authority at the Orlando International Airport, Orlando, Florida; and,

WHEREAS, the Authority desires and the Contractor agrees to amend the Contract to provide Airport Vision Site Expansion scope of work project revisions; and,

NOW, THEREFORE, for and in consideration of the premises and mutual covenants herein contained, the parties hereby amend the Contract as follows:

1. **Effective Date:** The effective date of this Amendment No. 18 shall be December 1, 2022.
2. **Contract Adjustment.** Contractor's Scope of Work shall be and hereby is adjusted to provide the Airport Vision Site Expansion. This includes deletion of services for the Holding Room Displays C25, Ticketing C14, Baggage Claim Totems C05, Customer Service Desk C10, Curbside C40, Overhead B33 & B34 and increasing services for Dynamic Gantry at Baggage Service Signs level 6 and Baggage claim Lightening Warning Notification, as identified on Attachment "A-18", Airport Vision Site Expansion Scope of Work Revisions.
3. **Compensation.** There is no additional compensation due from the Authority to the Contractor during the term of the Contract, for the scope of work revisions as detailed in Attachment "A-18", Airport Vision Site Expansion Scope of Work Revisions. Compensation shall be paid pursuant to the terms and conditions of the Contract.
4. **Suits/Proceedings.** New Contractor agrees that any suit or proceeding initiated for the purpose of interpreting or enforcing any provision of the Contract or any matter in connection therewith shall

be brought only in a court of competent jurisdiction in Orange County, Florida, New Contractor waives any venue objection, including, but not limited to, any objection that a suit has been brought in an inconvenient forum. New Contractor agrees to submit to the jurisdiction of the Florida courts and irrevocably agrees to accept service of process by U.S. mail.

5. Public Entity Crimes Act. New Contractor acknowledges the following notice: "A person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a contract to provide any goods or services to a public entity, may not submit a bid on a contract with a public entity for the construction or repair of a public building or public work, may not submit bids on leases of real property to a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount set forth in s.287.017, Florida Statutes, for CATEGORY TWO for a period of thirty-six (36) months from the date of being placed on the convicted vendor list."

6. Continuing Effect of Contract Provisions. Except as amended by this Amendment No. 18, the Contract shall continue in full force and effect in accordance with its terms and conditions.

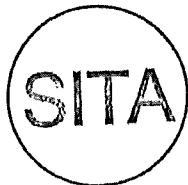
