# ITEM DESCRIPTION

Request for Recommendation of Approval of an Amendment to Addendum 47 to the Continuing Environmental Engineering Consulting Services Agreement with Terracon Consultants Inc. to provide Additional FY23 Industrial User Discharge Permit at Orlando International Airport.

# BACKGROUND

In 2018, the firms providing Continuing Environmental Engineering Consulting Services were selected through a competitive award process. These services are procured on an as-needed or annual basis.

On May 16, 2018, the Aviation Authority Board approved a Continuing Environmental Engineering Consulting Services Agreement with the following firms:

- AECOM Technical Services, Inc.
- MSE Group, LLC (MWBE)
- Professional Services Industries, Inc.
- Terracon Consultants, Inc.

These no-cost base agreements established the negotiated hourly rates. The services may include, but not limited to, environmental consulting services; conducting all phases of environmental contamination assessments for petroleum and hazardous materials; preparing reports and providing pertinent training as required by federal, State of Florida, and local agencies; storage tank management; coordination with regulatory agencies and remedial contractors; emergency response to fuel, petroleum and hazardous materials incidents, including immediate response to limit releases to the environment, performance of initial remedial actions and other related services including coordination with the Aviation Authority, its Consultants, the City and all agencies having jurisdiction over the Orlando International Airport, Orlando Executive Airport, and Other Facilities operated by the Aviation Authority.

The Services may also include, but are not limited to, studies and preparation of reports involving scope definition and validation of projects, analysis of environmental design parameters, budget development, evaluation and documentation of existing conditions; environmental design, bid/procurement and award, permitting, environmental construction administration, technical support and review of documents prepared by others, environmental management support on various Aviation Authority projects and all other environmental engineering and related professional services which may be required where the Aviation Authority elects not to solicit letters of interest by means of public advertisement.

# **ISSUES**

On September 27, 2022, the Construction Committee approved Addendum 47 to the above referenced agreement in the amount of \$21,809.00. Since that time, it has been determined that additional compliance activities pertaining to (GOAA)'s (IUDP) #CO106TA are required as furthered described in Consultant's proposal, dated March 8, 2023.

If approved, these services would be effective the date of Aviation Authority Board approval.

# **SMALL BUSINESS**

The MWBE/LDB/VBE participation has been reviewed by the Office of Small Business Development (OSBD). The findings and recommendation are attached.

# **ALTERNATIVES**

None.

# **FISCAL IMPACT**

The fiscal impact is \$30,556.00. Funding is from previously-approved Operations & Maintenance Budget.





# Re: Proposal for 2023 Industrial User Discharge Compliance Monitoring Activities

Dear Mr. Carrington:

As per your request, the following is Terracon's scope of services and associated costs for activities related to the continuation of compliance sampling, analyses and reporting activities at four (4) lift stations at the Orlando International Airport through September 30, 2023. This proposal outlines the project and presents the costs to perform the below described scope of services. The compliance monitoring activities are required pursuant to the Greater Orlando Aviation Authority's (GOAA) Industrial User Discharge Permit (IUDP) No. CO106TA issued by the City of Orlando (City).

# A. SCOPE OF SERVICES

# **Task 1: Installation of Sample Ports**

Access ports will be installed at each of the two (2) South Terminal lift stations to facilitate wastewater sampling activities. Installation of the sample ports will be performed by our subcontractor, Petrotech Southeast, Inc. (Petrotech) of Astatula, Florida.

# **Task 2: Compliance Monitoring**

Terracon will perform sampling, analysis and reporting activities at two (2) lift stations located at the North Terminal (LS # 218 and LS #221), and two (2) lift stations (LS #235 and LS #236) at Terminal C.

Pursuant to the IUDP requirements, the sample schedule will consist of the following events:

- June 2023: North Terminal LS#218 and LS #221 for chlorides
- July 2023: Terminal C LS #235 and LS #236 for chlorides and copper

Please note, resample events may be required by the City based on initial laboratory analytical results. For the purpose of this proposal, up to one (1) resample event has been included for each of the Lift Stations for copper and chlorides as applicable.

Each sampling event will generally consist of the following activities:

- 1. Set up and program a wastewater composite sampler at each of the lift stations for performance of a 24-hour composite sampling event.
- 2. Collect wastewater samples from each lift station upon completion of the 24-hour composite sampling process and deliver to a local State of Florida certified environmental laboratory for analytical testing. The wastewater samples will be properly transferred into the appropriate laboratory-supplied containers, dated, and preserved on wet ice prior and transported using chain-of-custody protocol to the laboratory.
- 3. The laboratory analytical testing services will be provided by Southern Research Laboratories, Inc. (SRL) of Orlando, Florida. The analysis for copper (metals) will be conducted by Environmental Protection Agency (EPA) 6010, and chloride by EPA Method 300.0.
- 4. Prepare monitoring reports for each sample event detailing the sampling methodology, field and analytical results and our conclusions and recommendations. Within five days of receipt of the laboratory analytical results, the report will be submitted to GOAA for review, approval and subsequent forwarding to the City of Orlando's permitting authority as required.

# **Commitment to Safety**

Terracon is committed to the safety of all its employees. As such, and in accordance with our Incident and Injury Free® safety culture, Terracon will develop a safety plan to be used by our personnel during field services. Prior to commencement of on-site activities, Terracon will hold a meeting to review health and safety needs for this specific project. At this time, we anticipate performing fieldwork in a modified USEPA Level D work uniform consisting of safety glasses, protective gloves, and steel-toed boots. It may become necessary to upgrade this level of protection, at additional cost, while sampling activities are being conducted in the event that petroleum or chemical constituents are encountered in soils or groundwater that present an increased risk for personal exposure.

# **Quality Assurance/Quality Control**

All field sampling activities will be performed by Terracon following the applicable procedures and requirements described in Florida Department of Environmental Protection's *Standard Operating Procedures for Field Activities*, DEP-SOP-001/01, effective April 16, 2018. Laboratory analyses will be conducted by MWBE-certified Southern Research Laboratories, Inc. (SRL), in general accordance with their National Environmental Laboratory Accreditation Program approved Quality Assurance Plan, certified by the Florida Department of Health.

# **B.** COMPENSATION

Terracon is prepared to implement the above generally outlined scope of services immediately upon your authorization and notice to proceed. Our total estimated cost to complete the project is a not to exceed amount of **\$30,556.00**, consisting of \$22,696.00 in Professional Service Fees and \$7,860.00 in Reimbursable Expenses as noted in **Attachment A**. 



# **BACKGROUND**

In 2018, the firms providing Continuing Environmental Engineering Consulting Services were selected through a competitive award process. These services are procured on an as-needed or annual basis. The Aviation Authority's policy and procedure provides that consulting firms may be engaged through continuing services agreements for construction projects with a value of \$4,000,000 or less.

On May 16, 2018, the Aviation Authority Board approved Continuing Environmental Engineering Consulting Services Agreements with the following five firms:

- AECOM Technical Services, Inc.
- MSE Group, LLC (MWBE)
- Professional Services Industries, Inc.
- Terracon Consultants, Inc.

These no-cost base agreements established the negotiated hourly rates. The services may include, but are not limited to, environmental consulting services; conducting all phases of environmental contamination assessments for petroleum and hazardous materials; preparing reports and providing pertinent training as required by federal, State of Florida, and local agencies; storage tank management; coordination with regulatory agencies and remedial contractors; emergency response to fuel, petroleum and hazardous materials incidents, including immediate response to limit releases to the environment, performance of initial remedial actions and other related services including coordination with the Aviation Authority, its Consultants, the City and all agencies having jurisdiction over the Orlando International Airport, Orlando Executive Airport, and Other Facilities operated by the Aviation Authority.

The Services may also include, but are not limited to, studies and preparation of reports involving scope definition and validation of projects, analysis of environmental design parameters, budget development, evaluation and documentation of existing conditions; environmental design, bid/procurement and award, permitting, environmental construction administration, technical support and review of documents prepared by others, environmental management support on various Aviation Authority projects and all other environmental engineering and related professional services which may be required where the Aviation Authority elects not to solicit letters of interest by means of public advertisement.

Addenda Nos. 1 through 52, and applicable amendments, to the Continuing Environmental Engineering Consulting Services Agreement with Terracon Consultants, Inc. have been approved. A summary of these approvals is on file with the Recording Secretary.

# **ISSUES**

A fee has been negotiated for an Amendment to Addendum No. 47 to the Continuing Environmental Engineering Consulting Services Agreement with Terracon Consultants, Inc. for the total amount of \$30,556, to provide additional FY 2023 Industrial User Discharge Permit (IUDP) Services at the Orlando International Airport (MCO). These services will provide additional compliance monitoring activities pertaining to the Aviation Authority's IUDP No. CO106TA issued by the City of Orlando and will include the continuation of compliance sampling, analyses and reporting activities at four lift stations at MCO through September 30, 2023.

On March 28, 2023, the Procurement Committee recommended approval of an Amendment to Addendum No. 47 to the Continuing Environmental Engineering Consulting Services Agreement with Terracon Consultants, Inc. for Additional Fiscal Year (FY) 2023 Industrial User Discharge Permit Services at the Orlando International Airport, as outlined in the memorandum.

As this amendment to Addendum No. 47 will result in an aggregate increase to the Aviation Authority's Agreement with Terracon Consultants, Inc. exceeding \$250,000, Aviation Authority Board approval is required.

# **SMALL BUSINESS**

The Aviation Authority has reviewed the proposal from Terracon Consultants, Inc., and determined that, because of the specialized nature of the scope of services to be provided, Terracon Consultants, Inc. proposes 1% Minority and Women Business Enterprise (MWBE) participation for laboratory analytical services. Terracon Consultants, Inc. is in good standing as it relates to its small business participation.

# **FISCAL IMPACT**

The fiscal impact is \$30,556. Funding is from previously-approved Operations and Maintenance Funds.

# **RECOMMENDED ACTION**

It is respectfully requested that the Aviation Authority Board resolve to accept the recommendation of the Procurement Committee and approve an Amendment to Addendum No. 47 to the Continuing Environmental Engineering Consulting Services Agreement with Terracon Consultants, Inc. for Additional FY 2023 Industrial User Discharge Permit Services at the Orlando International Airport, for the total amount of \$30,556, which includes the not-to-exceed fee amount of \$22,696 and the not-to-exceed expenses amount of \$7,860, with funding from previously-approved Operations and Maintenance Funds; and, authorize an Aviation Authority Officer or the Chief Executive Officer to execute the necessary documents following satisfactory review by legal counsel.
