THIS AMENDMENT is effective this 3rd day of October, 2023, by and between the **GREATER ORLANDO AVIATION AUTHORITY** ("Authority"), and **WSP USA INC.** ("Consultant").

WITNESSETH:

WHEREAS, by Agreement dated June 7, 2022, Authority and Consultant entered into an agreement for Consultant to provide Continuing Program and Project Management Services; and

WHEREAS, under the Agreement, Consultant agreed to perform such additional services for the Authority as are contained in any additional scope of work established by the Authority in any addendum to the Agreement and accepted in writing by the Consultant; and

WHEREAS, the Authority and the Consultant desire to enter into this Amendment to the Agreement to provide for additional services to be rendered by the Consultant under the terms of said Agreement.

NOW, THEREFORE, in consideration of the premises and the mutual covenants herein contained, the Authority and the Consultant do hereby agree as follows:

1. Consultant shall perform additional services in accordance with the terms of the Agreement and the attached Exhibit "A." Consultant shall be paid for such additional services according to the payment terms set forth in the Agreement.
2. Consultant shall be compensated for such additional services in the **NOT TO EXCEED** amount of **ONE HUNDRED SEVENTEEN THOUSAND FOUR HUNDRED AND NO/100 DOLLARS (\$117,400.00)**, broken down as follows:

Re: Request for Rescission of Prior Approval and Request for Approval of an Amendment to Addendum No.3 to the Continuing Program and Project Management Services Agreement with WSP USA Inc. to provide Program Management and Oversight OAR Services for W-00453 for Airsides 2 & 4 APM Program Oversight at Orlando International Airport

On May 30, 2023, the Construction Committee approved Addendum 3 in the amount of \$242,857.00 to the above-referenced agreement. On July 25, 2023, the Construction Committee approved Amendment No. 1 in the amount of \$93,177.00, extending the OAR services associated with BP-477 – APM Operating System (OS) Replacement for Airside 2 and 4 (DBOM)(BP-477) through September 30, 2023. On August 29, 2023, the Construction Committee approved item IV-L (Amendment No.2) in the Not to Exceed amount of \$1,929,320.00 for the Construction Phase Program Management and Oversight OAR Services for BP-477 from October 1, 2023, through September 30, 2024. The award of project BP-477 was anticipated to be presented at the September 27, 2023, GOAA Board meeting, but has been postponed until the October 18, 2023, GOAA Board meeting. Therefore, the pre-construction phase services are required to be extended to October 31, 2023, and Amendment No.2 should be rescinded and approved as further outlined in the consultant's September 19, 2023, proposal.

If approved, these services would be effective as of October 3, 2023.

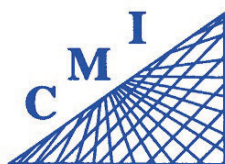

We have reviewed the qualifications of the subject contract's MWBE/LDB/VBE specifications and determined that WSP USA, Inc. proposes 54.5% MWBE and 2.7% LDB participation on this amendment.
