WHEREAS, under the Agreement, Consultant agreed to perform such additional services for the Authority as are contained in any additional scope of work established by the Authority in any addendum to the Agreement and accepted in writing by the Consultant; and

WHEREAS, the Authority and the Consultant desire to enter into this Addendum to the Agreement to provide for additional services to be rendered by the Consultant under the terms of said Agreement.

NOW, THEREFORE, in consideration of the premises and the mutual covenants herein contained, the Authority and the Consultant do hereby agree as follows:

1. Consultant shall perform additional services in accordance with the terms of the Agreement and the attached Exhibit "A." Consultant shall be paid for such additional services according to the payment terms set forth in the Agreement.

2. Consultant shall be compensated for such additional services in the **NOT TO EXCEED** amount of **FOUR HUNDRED FIFTY-EIGHT THOUSAND NINE HUNDRED FOUR AND NO/100 DOLLARS (\$458,904.00)**, broken down as follows:

3. A. Consultant hereby certifies that it is not on the Scrutinized Companies that Boycott Israel List and is not engaged in a boycott of Israel, as defined in Florida Statutes § 287.135, as amended;

AND

B. (applicable to agreements that may be \$1,000,000 or more) - Consultant hereby certifies that it is: (1) not on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List as defined in Florida Statutes § 287.135; and (2) not engaged in business operations in Cuba or Syria, as defined in Florida Statutes § 287.135, as amended.

4. Authority may terminate the Agreement for cause and without the opportunity to cure if the Consultant is found to have submitted a false certification or has been placed on the Scrutinized Companies that Boycott Israel List or is engaged in a boycott of Israel.

In the event the Agreement is for One Million Dollars (\$1,000,000.00) or more, Authority may terminate this Agreement for cause and without the opportunity to cure if the Consultant is found to have submitted a false certification or has been placed on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List or is engaged in business operations in Cuba or Syria.

5. Except as expressly modified in this Addendum, the Agreement dated February 23, 2021 and all prior addenda will remain in full force and effect.

BACKGROUND

In 2021, the firms providing Computer Aided Drafting (CAD), Geographic Information System (GIS), Building Information Modeling (BIM) and Related Services were selected through a competitive award process. These services are procured on an as-needed or annual basis.

Program Objective

Greater Orlando Aviation Authority manages Orlando International (MCO) and Orlando Executive (ORL) airports. The Aviation Authority over the years has amassed huge volumes of CAD and GIS data representing the airside and landside facilities at its airports. Over the past few years, GOAA has also been receiving BIM deliverables for major new construction like the SITF and Terminal C landside and airside buildings. A small group of CAD/GIS/BIM analysts currently handle all of the Authority's CAD/GIS/BIM needs. With Orlando International's a new terminal now being operational, and terminal expansion being currently planned, the Authority's need for skilled CAD, GIS & BIM staff is also increasing due to overall airport growth. GOAA has requested Woolpert for two on-site staff extension positions to support ongoing tasks related to CAD, GIS and BIM data development, updates and assisting Authority departmental staff with their data needs. These staff extensions will support GOAA with day to day graphics production, airspace analysis, address assignment, GIS data maintenance and development, planning support (such as airport layout plan updates), lease updates, Exhibit A property map updates, BIM model updates, BIM data extraction, BIM exhibit production, modifying existing BIM models to GOAA's BIM standards, reviewing incoming BIM deliverables, etc. Under this proposal Woolpert will provide two staff members to work as staff extension in GOAA offices.

Task 1: Plan and Manage Task

This task would involve project setup, project plan, invoicing and other administrative activities.

In addition, Woolpert will also provide one on site staff member to assist GOAA with day-to-day CAD and GIS related tasks. These tasks will include but not be limited to, CAD & GIS exhibit production, CAD & GIS data development, airspace analysis, address assignment, etc.

Assumptions:

- Woolpert staff member will work on site in GOAA's offices.
- GOAA will provide Woolpert staff member login credentials and access to GOAA's network as is necessary in performance of duties assigned.
- GOAA will provide Woolpert staff member with a dedicated workspace, including computer workstation and telephone assigned to this staff member, as well as access to printers & plotter and other peripherals as necessary.
- GOAA PM will provide Letter of Introduction necessary for obtaining GOAA badge for Woolpert's on-site staff member



Deliverables:

 Deliverables will be determined based tasks assigned during the course of day to day activities of the technical staff extension.

Task 3: On call Support

GOAA will advise Woolpert when services are required. Woolpert will assist GOAA with its on call support needs as they may arise. Support may include, but is not limited to the following:

- Airspace Analysis
- Addressing
- Data development
- Developing processes pertaining to CAD, GIS & BIM data
- Providing recommendations and solutions related to data and applications

Assumptions:

- GOAA will provide Woolpert with a written request for the services desired.
- GOAA will provide Woolpert access to data and/or GOAA's network as is necessary for completing the task.

ITEM DESCRIPTION

Recommendation of the Procurement Committee to Approve an Addendum to the Computer Aided Drafting (CAD), Geographic Information System (GIS), Building Information Modeling (BIM) and Related Services Agreement with Woolpert, Inc. for Fiscal Year (FY) 2024 CAD, GIS, BIM and Related Services

BACKGROUND

On February 2, 2021, the Aviation Authority Board approved CAD, GIS, BIM, and Related Consulting Services Agreements with the following firms, following a competitive award process in compliance with state statutes and Aviation Authority policies:

- CAD Concepts, Inc. dba CCI Engineering Services
- DRMP-AVCON JV, LLC
- EPIC Engineering and Consulting Group, LLC (MWBE/LDB)
- Montgomery Consulting Group, Inc. (MWBE/LDB)
- Woolpert, Inc.

The agreements are structured as a no-cost base agreement with negotiated hourly rates. Services that are within the advertised scope are negotiated on an as-needed or annual basis, and awarded as addenda to the base agreement. The terms of the agreements shall be for a period of three years with optional renewal periods of two additional one-year terms, to be exercised at the discretion of the Aviation Authority and accepted by both parties.

Woolpert, Inc. will provide services that include, but are not limited to, working in the Aviation Authority's offices and using the Aviation Authority equipment to perform and assist the Aviation Authority staff with the following services:

- Preparation and updating of the airport facility conceptual layout drawings, Airport Layout Plan (ALP) drawings, graphics, aerial photography and geospatial imagery, base maps, exhibits, floor plans, utility systems and building inventories.
- Integration and management of the airport facility data, airport addressing, land use maps, property surveys and maps, easements and leasehold exhibits, facility management data layers and data attributes, geospatial space planning systems and airport airspace.

ISSUES

A fee has been negotiated with Woolpert, Inc. for a total amount of \$458,904 for FY 2024 CAD, GIS, BIM and Related Services. These services include, but are not limited to, preparation of ongoing updates of CAD drawings and GIS data sets; database consolidation planning and data integration into the Aviation Authority's Enterprise GIS system; related GIS and CAD planning, analysis, and input as needed;

CONSENT AGENDA ITEM – L –

preparation and updating of the airport facility conceptual layout drawings, Airport Layout Plan (ALP) drawings, graphics, aerial photography and geospatial imagery, base maps, exhibits, floor plans, utility systems and building inventories; integration and management of the airport facility data, airport addressing, land use maps, property surveys and maps, easements and leasehold exhibits, facility management data layers and data attributes, geospatial space planning systems and airport airspace; and, assistance of Aviation Authority staff on various projects as requested. Services will be provided from October 1, 2023, through September 30, 2024. At the discretion of the Aviation Authority, the level of provided services may be adjusted during the fiscal year, depending on fluctuations of Aviation Authority staffing levels.

On August 1, 2023, the Procurement Committee recommended approval of an Addendum to the CAD, GIS, BIM and Related Services Agreement with Woolpert, Inc. for FY 2024 CAD, GIS, BIM and Related Services, as outlined in the memorandum.

SMALL BUSINESS

The Aviation Authority has reviewed the proposal from Woolpert, Inc., and determined that, due to the onsite staffing support services, Woolpert, Inc. does not propose any MWBE/LDB/VBE participation on this addendum, and certifies that Woolpert, Inc. is in good standing as it relates to its small business participation.

FISCAL IMPACT

The fiscal impact is \$458,904. Funding is from Operations and Maintenance Fund (subject to adoption of the FY 2024 Aviation Authority Budget by the Aviation Authority Board under separate item).
