For individuals who conduct lobbying activities with Aviation Authority employees or Board members, registration with the Aviation Authority is required each year prior to conducting any lobbying activities. A statement of expenditures incurred in connection with those lobbying instances should also be filed prior to April 1 of each year for the preceding year. Lobbying any Aviation Authority Staff who are members of any committee responsible for ranking Proposals, Letters of Interest, Statements of Qualifications or Bids and thereafter forwarding those recommendations to the Board and/or Board Members is prohibited from the time that a Request for Proposals, Request for Letters of Interests, Request for Qualifications or Request for Bids is released to the time that the Board makes an award. The lobbyist shall file a Notice of Lobbying (Form 4) detailing each instance of lobbying to the Aviation Authority within 7 calendar days of such lobbying. Lobbyists will also provide a notice to the Aviation Authority when meeting with the Mayor of the City of Orlando or the Mayor of Orange County at their offices. #### ITEM DESCRIPTION

Recommendation to Accept Public Transportation Grant Agreements (PTGAs) for Orlando International Airport (MCO) and Orlando Executive Airport (ORL) from the Florida Department of Transportation (FDOT)

#### **BACKGROUND**

Throughout the year, the Florida Department of Transportation (FDOT) provides grants (i.e., PTGAs) to match funds with the Aviation Authority for certain projects in accordance with the Aviation Authority's Capital Improvement Program (CIP).

#### **ISSUES**

The Aviation Authority has received the following:

### Orlando International Airport

Amendment No. 4-2 to Public Transportation Grant Agreement FM 448578-1-94-01. This
 Amendment in the amount of \$1,000,000 provides additional 50% funding for design and
 construction phase services for Terminal C.

#### Orlando Executive Airport

 Public Transportation Grant Agreement FM 450788-1-94-01. This PTGA in the amount of \$340,000 provides 80% funding for design and construction funding for the rehabilitation of the East Ramp Phase 1A. The project is located south of the GOAA ORL Administration Building in the north central part of the airport property. The East Ramp was constructed in 1984 and last resealed in 2007. This is the first phase of a multi-phase program.

#### **ALTERNATIVES**

None.

### **FISCAL IMPACT**

The fiscal impact is the acceptance of FDOT funding in the amount of \$1,340,000. Aviation Authority's matching funds in the amount of \$1,000,000 will be from Passenger-Customer Facility Charges to the extent eligible and General Airport Revenue Bonds, and matching funds in the amount of \$85,000 will be from ORL Revenue Funds.

## **RECOMMENDED ACTION**

It is respectfully requested that the Aviation Authority Board ratify the Resolutions accepting Amendment 4-2 to PTGA FM 448578-94-01 and PTGA FM 450788-1-94-01 and authorize the Chief Executive Officer and the Assistant Secretary to execute the necessary documents.
